

**General Terms and Conditions to Bidders**

Apart of condition given in "NIT" and instruction to bidding document, following terms and condition are applicable or binding upon bidders / contractors / firms. (amended 2013).

**ELIGIBILITY / EVALUATION CRITERIA:**

1. The bidder / Contractor should have valid NTN, Sales Tax Registration and Sindh Revenue Board Registration.
2. The bidder / Contractor should be registered with Pakistan engineering council with upto date renewal for the year 2015-16 licence as per Rule-46(1)-(a)-(iii) of SPPRA rule 2010 (amended 2013), as the case may be.
3. The bidder / Contractor shall attach three year related work experience certificate alongwith bank statement showing last three years turnover with tender documents / bids.
4. The bidder / Contractor must quote the rates both in words and figure with accuracy. Any over writing or intangible writing will not be accepted and liable to rejection of tender / bid.
5. The sealed bids / tender document complete in all respect must reach on or before the scheduled date time and manner at the address of Procuring Agency given in the "NIT".
6. In case of date of opening of tender / bid, declared holiday or non working day, the next official working day shall be deemed to the date of submission and opening of tenders at the same time and venue.
7. Conditional or forged bids / tenders are not acceptable and liable to rejection without any excuse.
8. Bidders / Contractors shall be excluded from the process of bidding / NIT if involved in "corrupt and fraudulent practices" in any form.


