Applications for pre-qualification are invited from reputed contractor/ firm having experience in Earthwork, Structures, Stone Pitching, C.C Lining of Canals/ Channel & Minors and having license/ registration with Pakistan Engineering Council in the category C-3 (up to 400 million rupees) and above valid for the year 2015-16 to carry out the works under Makhi Farash Link Canal Project (Chotiari Phase-II) for Water Supply to Thar Coal in Chotiari Reservoir Project Circle at Sanghar. The nature of work includes Earthwork, Structures, Stone Pitching, and C.C Lining of Canal / Channel & Minors and etc.

In pursuance to SPPRA Rules clause 18 (1&2) and looking to the scope, magnitude of the Project due consideration is given to ensure minimum Response time of fifteen (15) days therefore, the intending Firms are advised to collect the Prequalification Documents from February 10, 2016. The firms should return the Pre-Qualification documents duly filled up to February 27, 2016. The Tender documents will be available in the office of the Project Director/ SE, Chotiari Reservoir Project Circle Sanghar, Camp Office at Left Bank Barrage Colony Hyderabad on the payment of Rs 3,000/- Only (Non Refundable).

The Tender documents will be considered and evaluated in accordance with SPPRA Rules 2010 (amended 2013). The intending contractors may obtain any further information regarding the project on any working day before the last date of submission. The tender documents in English language shall be submitted in three copies (03) (One Original + 2 Copies) to reach the Office of undersigned in sealed cover on or before 27th February, 2016 at 2.00 PM. The same will be opened in the office of undersigned on the same day at 3:00 PM in the presence of authorized representatives of the firms who wish to present and the Committee.

The intended contractor/ firm can apply either in consortium or as a single entity. The consortium consisting more than three (03) firms shall not be eligible for participation. If the firms do not provide the full information as required in the Pre-qualification document, the application shall be considered as non responsive. Further the intended contractor/ firm has to submit the undertaking for completing the work within stipulated period of time as fixed by the Procuring Agency.

Contractor should also provide undertaking on the letter head that the cumulative cost of the running works is not beyond the approved limit of the contractor. In the case, the contractor if already engaged in works bearing the substantial cost of his capacity will not be considered financially eligible for the Tendering process.

Conditional and late application shall not be entertained. The Procuring Agency reserves the right to accept or reject any or all Tenders under relevant provisions of SPPRA Rules.
