Technical Proposals of the participating firms will be opened on the same day at 01:00 p.m. by the Procurement Committee in presence of participating contractors/authorized representatives of the firms who wish to be present. In case of tender un-responded the same will be issued on 02-03-2016 upto 02:00 p.m. and will received back on 03-03-2016 upto 12:00 noon and opened on same day at 01:00 p.m. and issued on 04-03-2016 upto 02:00 p.m. and received back on 07-03-2016 upto 12:00 noon and will open on same day at 01:00 p.m.

The Technical Proposals so opened shall be evaluated for technical qualification of the firms. Financial Proposals of technically qualified firms shall be opened and publically announced on the date and time that will be communicated in writing to all the qualified contractors/firms in advance. Financial Proposals of technically unqualified contractors shall be returned to them un-opened.

Tender should be carefully and neatly filled and signed by the bidders each bid must accompany earnest money as mentioned below in shape deposit at call in favour of **DDO Commissioner Shaheed Benazirabad Division**. Bid security shall be submitted in the sealed envelope named “Financial Proposals”.

5% performance guarantee of quoted bid of scheduled bank must also be accompanied. Validity of performance security shall extend at least Ninety days beyond the date of completion of contract to cover defects liability period or maintenance period subject to final acceptance by the procuring agency.

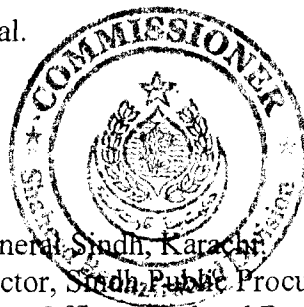

## CONDITION OF CONTRACT

1. Specifications means the specifications of the works included in the contract and any modification or addition made or approved by the employer. In case of supplies the suppliers shall furnish complete technical details and brochures along with warranty etc; while quoting their rates for the specific make & model.
2. The Start date is within seven days of issue of letter of award.
3. In interpretation of these conditions, singular also means plural, male also means female or neuter, and the other way around. Headings have no significance. Words have their normal meaning under the language of the contract unless specifically defined. The employer will provide instructions clarifying queries about these conditions of contract.
4. The documents forming the Contract shall be interpreted in the following order of priority;
  - a. Agreement on Non-Judicial Stamp Paper.
  - b. Letter of Award.
  - c. Contractor's Bid.
  - d. Contract Data.
  - e. Conditions of Contract.
  - f. Specifications.
  - g. Any other documents listed in the Contract Data as forming part of the contract.
5. Except where otherwise specifically stated, the Commissioner, Shaheed Benazirabad Division @ Nawabshah (hereinafter called the competent authority) will decide contractual matter.
6. The concerned Assistant Commissioner may delegate any of his duties and responsibilities to other people after notifying to the Contractor, and may cancel any such delegation after notifying to the Contractor.
7. Communication between parties that are referred to in the Conditions shall be effective only when in writing, A notice shall be effective only when it is delivered.
8. The Contractor may subcontract with the approval of the concerned Assistant Commissioner, but may not assign the contract without the approval of the competent authority in writing subcontracting shall not alter the Contractor's obligations.

9. The competent authority will clarify queries on the contract data.
10. The contractor shall construct and install the works in accordance with the specifications and Drawings provided or approved by the executing agency.
11. The contractor may commence execution of the works on the start date and shall carry out the works in accordance with the programme submitted by the contractor as updated with the approval of the competent authority and complete them by the stipulated completion date.
12. The contractor shall carryout all instructions of the competent authority and his authorized representative which comply with the applicable laws where the site is located.
13. The concerned Assistant Commissioner shall check the contractor's work and notify the contractor of any Defects that are found. Such checking shall not affect the contractor's responsibilities.
14. The concerned authority shall give notice to the contractor of any Defect before the end of the Defect Liability Period, which begins at completion and is defied in the contract Data. The Defect Liability Period shall be extended for as long as Defect remain to be corrected.
15. Every time a notice of Defect is given, the contractor shall correct the notified Defect within the length of time specified by the employer.
16. If the contractor has not corrected a defect within the time specified in the AC's notice the employer will assess the cost of having the defect corrected, and the contractor will pay this amount, or it will be adjusted from his securities with the employer.
17. The value of work executed shall comprise the value of the quantities of the items in the Schedule "B" of the contract.
18. Items of the works for which no rate or price has been entered in the tender will not be paid by the Project Director and shall be deemed covered by other rates and prices in the contract.
19. Income Tax, Sale Tax or any other liable tax shall be deducted as per prevailing government rules.
20. Failure of the contractor / supplier to complete the work / supplies in the agreed / notified time frame will make sufficient ground for the forfeiture of Bid and other securities by the employer.
