



The Functions & Responsibilities of the Committee as specified in Rules-31(4) and (5) of Public Procurement Rules-2010 (Amended 2013) are as under:-

(14): The complaint redressal committee upon receiving a complaint from an aggrieved bidder may, if satisfied;

- (a) prohibit the procurement committee from acting or continuing in a manner, inconsistent with these rules and regulation;
- (b) annul in whole or in part, any unauthorized act or decision of the procurement committee; and
- (c) recommend to the Head of Department that the case be declared a procurement violation if material violation of act, Rules, Regulations, Orders, instructions or any other law relating to public procurement, has been established; and;
- (d) reverse any decision of the procurement committee or substitute its own decision for such a decision;

Provided that the complaint redressal committee shall not make any decision to award the contract.

(15): The complaint redressal committee shall announce its decision within seven days and initiate the same to the bidder and the Authority within three working days. If the committee fails to arrive at the decision within seven days, the complaint shall stand transferred to the Review Committee, which shall dispose of the complaint in accordance with the procedure laid down in rule-32.
