2. The DDWP of Ministry of Water & Power, while considering the flood related schemes in its meeting held on 7th January, 2016 took the following decision:-

"The forum approved these schemes against their respective cost subject to compliance of observations of Scrutinizing Committee of Federal Flood Commission and other codal formalities. Moreover, Secretary, Irrigation Department Sindh will furnish a certificate that there is no restoration and rehabilitation works in these PC-I's".

3. In pursuance of DDWP decision, Federal Flood Commission has conveyed that all the observations of Scrutinizing Committee have been complied and all the codal formalities will be observed by Executing Agency before execution. Secretary Irrigation Department, Government of Sindh (executing agency) has furnished certificate that no restoration and rehabilitation work is involved.

4. The monthly progress report in respect of the above mentioned project may be submitted regularly.

5. All codal formalities and guidelines shall be observed strictly while implementing the scheme. The Ministry of Water & Power shall be kept on board during all the important stages involved in the project life cycle.






