The chair sharing the existing infrastructure scenario of District Karachi West, said that the schemes should be prioritized to provide immediate relief & services to the people. Various aspects of Community Development Program under Sustainable Development Goals-2015-16 were also shared. Thereafter the Engineers from DMC Karachi West, KW&SB and Provincial Works & Services gave detailed briefing about their proposed schemes to be carried out under Community Development Program for Sustainable Development Goals for 2015-16.

It was informed by the Engineers that the proposed schemes carry standard estimates as per Sindh Schedule rates-2012 and all codal formalities have been strictly complied for the preparation of the PC-I.
