If any fake documents found then CDGK is liable to reject / cancel the tender / work without any compensation and penalize as per rules. 2% Earnest Money in shape of pay order / Bank Guarantee from any schedule Bank as mentioned above should also be enclosed along with the application for issuance of tender documents failing which tender documents will not be issued. Earnest Money equal to 2% of the offer amount of the work should be enclosed along with tender in shape of pay order / Bank Guarantee from any schedule bank in favor of CDGK. No tender will be sold on the tender opening date.

The tender in sealed cover superscripted with the name of work should be dropped in the tender box kept in the office of the Executive District Officer (Works & Services) 4th Floor, Civic Center, University Road, Gulshan-e-Iqbal, Karachi by 2:00 pm on 21-05-2009 and opened on the same day at 2:30 pm in the Committee Room of Works & Services Department, CDGK 4th Floor, Civic Center, University Road, Gulshan-e-Iqbal, Karachi in presence of those bidders or their representative who wish to be present.

In case of any reason, if the tenders could not be opened on the above dates the next date of opening will be 28-05-2009 and the tender documents will also be available for sale up to 27-05-2009.


In Case the date of opening declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the time as mentioned above.
