The Karachi Water & Sewerage Board invites sealed tenders on the prescribed form from the eligible Firm / Contractors /Manufacturers/ Sole Agent on Single Stage Two Envelops Procedure on PPRA-2004 for the computer system installed in towns and city offices of KW&SB to maintain the monthly billing to customers services for the following work:-

1.	Name of Work	Repairing and Maintenance Computer System i.e. Pentium-IV, Printer Epson LX-300+II, Stabilizer, UPS with the installation of SCO OPEN SERVER with disaster recovery and updating of Data on monthly basis with Parts.
2.	Eligibility	Firm / Contractors /Manufacturers/ Sole Agent and license category of PEC at least in C-6.
3	Budget Provision	KW&SB Budget.
4.	Tenders can be purchased	Prescribed tender documents along-with the terms & conditions can be obtained on the payment of Rs.1000/- against Pay Order / Bank Draft (Non-refundable) in favour of Karachi Water & Sewerage Board on the production of the written application from the office the Director Planning situated in Block "E" 9 th Mile, Karsaz Karachi , A.O Revenue, Ist Floor, Old KBCA Building behind Civic Center , Gulshan –e- Iqbal, Karachi.
5	Date of issue of the tender documents.	Tender documents will be issued from the date of publication on the Web Sites to 19-05-2009 and no tender documents will be issued on the date of opening.
		The bidding shall be on " Single Stage-two-envelops procedure:-
	(i)	Ist envelope should be contained Technical proposal only and be clearly marked " TECHNICAL PROPOSAL ".
	(ii)	2 nd envelope should be contained " FINANCIAL PROPOSAL " along-with the 2 % Earnest Money of the quoted offer in shape of pay order/bank draft (refundable to unsuccessful bidders) in favour of Karachi Water & Sewerage Board.
	(iii)	Both Envelops should be sealed separately and placed in the 3 rd envelope. The name of the bidder and subject of the tender be clearly marked on all envelopes.
6	Date of Receiving / Opening Of Tender	Tender should be dropped in the tender box kept in the office of the Director (I.T) at Room No. 72, 3 rd Floor, Old KBCA Building Behind Civic Center, Gulshan-e-Iqbal , Karachi on 20-05-2009 at 2.00 p.m and opened at 2.30 p.m on the same day in the presence of bidders or their nominated representatives, who wish to attend.
After the evaluation and approval of the technical proposal the Karachi Water & Sewerage Board within the validity for minimum of 60 days publicly open the financial proposals of the technically accepted bids only. The financial proposal of the bids found non-responsive shall be returned unopened to the respective bidder.
