- 2. Language of Bid
- 2.1 The bid prepared by the Bidder, as well as all correspondence and documents relating to the bid exchanged by the Bidder and procuring agency, shall be written in English. Sindhi or teller language.
- 3. Documents comprising the Bid
- 3.1 The bid prepared by the Bidder shall comprise the following components:
  - (a) Price schedule completed in accordance with ITB Clauses 4. 5 and 6.
  - (b) Bid security furnished in accordance with ITB Clause 8
- 4. Bid Prices
- 4.1 The Bidder shall indicate on the appropriate Price Schedule the unit prices (where applicable) and total bid price of the goods it proposes to supply under the contract.
- 4.2 The prices shall be quoted on delivery to consignee's end incloses of all taxes, stamps, duties, levies, fees and installation and integration charges imposed till the delivery location specified in the Schedule of Requirements. No separate payment shall be made be incidental services.
- 4.3 Prices quoted by the Bidder shall be fixed during the Bidder's performance of the contract and not subject to variation on an account, unless otherwise specified in the Bid Data Sheet

- 11.2 If the outer envelope is not sealed and marked as required, the Procuring agency assume no responsibility for the bid's misplacement or premature opening.
- 12 Deadline for submission of Bids
- 12.1 Bids must be received by the Procuring agency at the address specified in BDS, not later than the time and date specified in the Bid Data Sheet.
- 12.2 The procuring agency may, at its discretion, extend this deadline for the submission of bids by amending the bidding documents in such case all rights and obligations of the Procuring agency and bidder previously subject to the deadline will thereafter be subject to the deadline as extended.
- 13. Late Bids
- 13.1 Any bids received by the Procuring agency after the deadline for submission of bids prescribed by the procuring agency shall be rejected and returned unopened to the Bidder.
- 14. Modification and withdrawal of Bids
- 14.1 The Bidder may modify or withdraw its bid after the Bid's submission, provided that written notice of the modification, including substitution or withdrawal of the bids, is received by the procuring agency prior to the deadline prescribed for submission of bids.
- 14.2 No bid may be modified after the deadline for submission of bids.
- 14.3 No bid may be withdrawn in the interval between the deadline for submission of bids and the expiry of the period of bids validity. Withdrawal of a bid during this interval may result in the Bidden's forfeiture of its bid security.

#### Opening and Evaluation of Bids

- 15. Opening of Bids by the procuring agency
- 15.1 The Procuring agency shall open all bids in the presence of bidder's representatives who choose to attend, at the time, on the date, and at the place specified in the Bid Data Sheet.
