## **REVITALIZATION OF MECHANICAL WING OF IRRIGATION DEPARTMENT**

### **GENERAL NOTE**

By the grace of Almighty ALLAH no doubt that the Sindh is the gift of Mighty Indus River. The network of Irrigation system is managed with the help of majestic of three Barrages i.e. i) Irrigation Gudu Barrage, Irrigation Sukkur Barrage and Irrigation Kotri Barrage in the province of Sindh. The earth moving machinery of Mechanical Wing of Irrigation Department plays a vital role to maintain such a vast network of Canal system of all three dynamic Barrages.

The Machinery of Mechanical wing is supposed to undertake the works of Irrigation system such as, Construction and strengthening of Flood Protection Bund, De-silting of canals etc. The existing fleets of earthmoving machinery of the Department are required to meet the above mention task and face the challenges to combat the super flood emergency work and heavy rain fall during the moon soon season.

In order to ensure the preventive measure of Irrigation network system, it is necessary to reinforce and keep the machine in order for the smooth operation and maintenance of machinery of this Department as well as the offices of Officers and Officials for smoothing running of Government Work.

The Mechanical Circle-II, Mirpurkhas @ Jamshoro has only one Division namely Lower Sindh Mechanical Division, Jamshoro and there 03 Sub-Divisional Offices, i.e. Dragline Sub-Divisor, Jamshoro, ii) Dredger Sub-Division, Jamshoro and iii) Pumping Sub-Division, Jamshoro.

The Mechanical Circle-II, Mirpurkhas @ Jamshoro has newly been created during the year 2014 and there is no any Building to Superintending Engineer, further with the passage of time and heavy rains during year 2010, the Office blocks of Lower Sindh Mechanical Division, Jamshoro and its 03 Nos. Sub-Divisions at Jamshoro damaged badly and the existing buildings have completed its life. The Boundary walls have been collapsed / damaged. The building requires urgent repair and maintenance so that the lives of more than 361 employees and precious Office record may be got save and construction of boundary walls is also necessary for watch and ward / Security measures to safeguard the Government property.

The Constructions of Office Blocks / Building Boundary Walls / Maintenance of Heavy earth moving machinery / vehicles are very essential , hence PC-1 amounting to Rs.50.000 Million has been prepare and submitted for the approval from the competent forum i.e. ADP.




