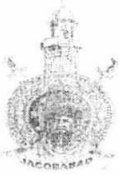

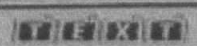

2. in this tender method of procurement, as per SPPRA 2010 will be **ONE STAGE TWO ENVELOPE PROCEDURE** (Bid should be submitted in a single package containing separately the technical proposal and the financial proposal)
3. Envelops should be marked as "**TECHNICAL PROPOSAL**" and "**FINANCIAL PROSPOSAL**" in bold and legible / readable letters
4. Proof of payment of cost of tender shall be required at the time of opening the tender original receipt must be attached with the tender
