Each envelope must clearly be marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" in bold and legible letters to avoid confusion.
- 2. Initially only the envelope marked "TECHNICAL PROPOSAL" shall be opened.
- 3. The envelope marked as "FINANCIAL PROPOSAL" shall be retained in the custody of procuring agency without being opened.
- 4. During the technical evaluation no amendments in the technical proposal shall be permitted.
- 5. The financial proposal of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance.
- 6. After the evaluation and approval of the technical proposal the procuring agency shall at a time within the bid validity period publicly open the financial proposal of the technically accepted bids only. The financial proposals of bids found technically non responsive shall be returned unopened to the respective bidders.
- 7. Tenders are required to be furnished with earnest money of 2.5% of total value of bid in form of pay order / Call Deposit in favour of the Director Plant Protection, Agriculture Extension Sindh, Hyderabad in sealed envelop.
- 8. The Contractor is bound to deliver the stores / goods within the delivery period other wise his security deposit will be forfeited and he shall be dealt with according to rules.
- 9. The Supplier shall obtain and submit to Buyer within 7 days of the acceptance of his tender, a bond in the value of 5% of the amount of supply order in the form of Bank guarantee at his own expenses, with the text to be approved by the Buyer. By not doing so the deposit of the performance bond shall be revert in favour of the Buyer.
