- 2. The University would adopt Single Stage two envelope procedure. The bidder should submit Two Separate Sealed Envelopes. One envelope should contain the technical proposal and the other envelope contain the financial proposal. Both envelopes should be clearly marked "TECHNICAL PROPOSAL" & "FINANCIAL PROPOSAL" in bold and legible letters.
- 3. The rates quoted should be inclusive of GST, Income Tax etc. GST will be deducted at source as prescribed rates. Delivery & installation of the above articles will be made at Sindh Agriculture University, Tandojam at serial No: 1 and Shaheed Z.A Bhutto Agricultural College, Dokri at Serial No: 2.
- 4. The bidders are required to give their best & final prices without any negotiations which must be valid for 60-days after submission of bids.
- 5. The Technically successful bidders should have to give a presentation before opening of financial bids.

TERMS AND CONDITIONS

Companies are requested to read carefully the following terms and conditions and sign the Tender Form in token of having understood and accepted the same in all respects. They are also requested to submit the bid/bids complete in all respects. Tender without 5% earnest money will be out-rightly rejected.

- 1. The bid documents should be submitted in two separate envelopes, i.e. Single Stage Two Envelops (i. Technical, ii. Financial)
- 2. The Company should quote their rates against each item sequence wise in the official format of tender document based on the Invoice/Quotation.
- 3. documents.
- 4. The Bidder has to provide prices as per BOQ & total with GST.
- 5. The Company should produce call deposit / Bid Security 5% of the offered bid in the shape of Pay Order /Bank Draft in the name of Sindh Agriculture University, Tandojam, if failure the tender document will not be entertained.
- 6. The Company must be Registered with Income Tax Department (Valid NTN Certificate)
- 7. The Company must be Registered with Sales Tax Department (Valid SRB&GST Certificate)
- 8. The Company must have supplied and installed similar type of Equipment/projects in the country (atleast 3 projects).
- 9. The Company must have 5 years + experience of similar projects.

2. SCOPE OF WORK

Following requirements define the scope of the work of this tender:

- 1. The Selected Bidder will be responsible for the supply, installation, configuration, integration, testing and commissioning of supply equipment in Sindh Agriculture University, Tandojam and Shaheed Z.A Bhutto Agricultural College, Dokri.
- 2. Selected Bidder must ensure that the supplied equipment is operational, new, perform properly, and meet RFP's Technical Specification and it is not going to be EOF & End of support for next five years and equipment parts remain available with the vendor for said period.
- 3. Official Hands on Training for nominating professional staff of Sindh Agriculture University.
- 4. At the time/end of installation and commissioning, Selected Bidder must provide comprehensive documentation of Configuration and Manuals etc.
- 5. The selected bidder shall be responsible for the provisioning of extended warranties and services.
- 6. The selected bidder will be responsible to respond to events on an urgent basis as per SLA mention to this RFP.
- 7. Selected bidder may be assigned responsibilities initially for 1 years of Services.

3. SELECTION PROCEDURE

- 1. A two step process will be used for the selection of a bidder for the award of this tender.
- 2. Sindh Agriculture University intent in issuing this Tender Document is to award a contract to the best evaluated and best responsive bidder who meets the specifications as laid out in Technical information and who fulfill all Mandatory Requirements mentioned in the General Terms and Conditions. If any of the requirements or equipment specifications is not met by the bidder, the bid will be considered as non-responsive, and the bid of the next bidder will be considered.
- 3. The selection criteria have been given separately, i.e. bid evaluation process.
- 4. After the approval of contract award, a contract agreement on the stamp paper worth Rs. 100/- shall be executed by the firm with selected bidders within 15 days from the date of issuance of Letter of Intent.

4. OEM Relationships & Warranties

1. The responding organization (RO) should be an authorized business partner from the ORIGINAL EQUIPMENT MANUFACTURER (OEM), for the proposed hardware, software or networking components and other equipments in Pakistan. A certificate to their effect should be included in the proposal, otherwise the bid is liable to be rejected.

2.Selected vendor will provide maintenance / support service, after expiry of warranty, for each category of products identified. However, Sindh University will not be bound to avail this service.

3. The equipment should be supplied through a verifiable distribution channel in Pakistan.

5. TERMS OF PAYMENT

- 1. No payment shall be made in advance to the Contractor/Firm as mobilization advance.
- 2. Two Percent (2%) of the payable amount against each invoice/payment will be retained as security/retention money. 2% retained money will be released after successful completion of 1st year warranty Services. Or contractor may submit or extend performance bank guarantee of equivalent amount which will be released after 1st year of warranty services.
- 3. Payments shall be made through cross cheque in the Pak Rupees.
- 4. Taxes will be deducted at source as per government rules at the time of payment.
- 5. The 5% earnest money of the successful bidder will be retained up-to 90-days after the completion of the job.
