

Clause 5 Clarification and Modification of Documents

Clause 6 Addendum: At any time prior to the deadline for submission of Prequalification Documents, the PA may amend the Prequalification Document by issuing addenda. Any addendum issued shall be part of the Prequalification Document and shall be communicated in writing to all who have obtained the prequalification document.
