
3. Eligibility / Conditions:-

- Documentary evidence of work of equivalent cost or above executed in last 3 years and Certificate of satisfactory completion showing date of start and completion from employer.
Registration with Income Tax Department (NTN copy) and Sindh Revenue Board, (Sales Tax Registration) and copy of CNIC.
- ii. The application Shall accompany of tender fee as shown against each for purchase of bidding documents.
 - iv. The 5% Earnest money shall be submitted in the shape of call deposit issued from scheduled bank at the time of submission of bidding document in favor of undersigned.
 - v. Certificate of bank showing credit worthiness along with current bank statement.
 - vi. Affidavit to the effect that firm has not been black listed previously by any executing agency.
 - vii. Affidavits to the effect that all documents / particulars / information furnished are true and correct.
 - viii. Conditional Tenders will not be entertained.
 - ix. Advertisement can be seen on Sindh Government web site (www.Sindh.gov.pk) and SPPRA web site.
 - x) Undertaking on stamp paper that firm is not involved in any kind of litigation, departmental rift, abandoned or unnecessary delay in completion of any work in the Government and as well as in private organizations.
