 - (vi) Detail of each earth moving machinery and transport in good order owned by the firm / contractor.
 - (vii) Valid income tax registration and clearance certificate issued by Federal Board of Revenue.
 - (viii) Valid registration in clearance certificate issued by Sindh Revenue Board (SRB)
 - (ix) Financial status with annual turnover / transaction for at least minimum Rs: 150 (M) showing current assets / balance & liabilities duly supported and authenticated.
 - (x) The contractor / firm should submit annual Bank statement for last 3 years.
 - (xi) Solvency certificate of any reputed scheduled bank for minimum RS 100 (M) or above required.
4. An affidavit that the contractor / firm have never been black listed by any agency.
 5. In affidavit giving status of any dispute / arbitration of Civil suites.


