Auditorium (for 1000 person) ii. Dining hall with Cook House iii. Cafeteria (for 200 person) iv. Indoor sports complex v. Officers Mess (250 person) vi. 03 No. Flats (G+2) vii. 24 Flats (4x6) (G+2) viii. Cat-A Bungalow ix. Squash Court (04 No.) x. Establishment of Parks and Grounds Details of the project can be obtained from the office of Principal/PD, Public School Hyderabad within 5 days from the date of publishing in Newspapers with demand draft of Rs.3000/= (Non-refundable fee) from any schedule Bank of Pakistan in favour of Principal/PD Public School Hyderabad.

The interested contractors/firms duly registered with Pakistan Engineering Council in appropriate categories having valid registration may apply to the undersigned upto 25 February 2017. for pre qualification/short listing.

### Required documents:-

1. Complete name, address of firm (with telephone / Fax No. & E-mail etc.), and whether the firm is partnership or limited company with name of Partners/Directors and Registration of Partnership/Memorandum of Association/Incorporation-etc.
2. Registration/renewal and prequalification with government, semi-government departments and autonomous bodies.
3. Projects of similar nature already completed within the last 5 years, including work orders and completion certificates, where the value of the bidder participation exceeds Rs. 200 million.
4. The bidders should have cash flow of 100 million with necessary proof.
5. Projects of similar nature in hand with the work orders.
6. List of technical staff including Graduate Engineers, Diploma Holders with all relevant details.

7. List of tools and plants with detail of Make and Model.
8. Evidence showing financial soundness of the contractor/firm bank statement of 5 years including audit and balance sheet of relevant accounts of last 5 years.
9. Affidavit on stamp paper that the contractor/firm have never been black listed by any government, semi-government or private organization.
10. Certificate of registration of contractor/firm with FBR/SRB.

### Rules & Regulations:

- a. The Competent authority reserves the right to reject any application without assigning any reason.
- b. Any concealment about the information/details mentioned above will result in disqualification of consultant firm.
- c. In case of incomplete information, pre qualification application will be rejected and will not be considered.
- d. No Court proceeding against the competent authority will be allowed and the decision taken will be final.
- e. Applicant, contractor firm are required to give guarantee/ undertaking that they have carefully studied the pre qualification notice and will abide by the rules & regulations.

### Any of the total contractor firm can only be rejected on the basis of evaluation criteria through:

- a. The procuring agency may reject contractor firm at any time prior to the acceptance of a bid or proposal.
- b. The procuring agency shall upon request communicate to any contractor firm, the grounds for its rejection, but shall not be required to justify those grounds.
