INSTRUCTIONS:

1. Single-Stage — Two-Envelope Procedure will be adopted for the tender process. The bid shall comprise of a single package containing two envelopes. Each envelope shall contain separately sealed financial proposal and technical proposal. Envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion.
2. The interested manufacturers / suppliers and authorized dealers may obtain the tender document along with tender fee of Rs. 500/- each item from Mr. Arif Shah, Assistant Sub-Inspector of Special Branch Karachi Cell No. 0300-9252074 & Office No. 021-99212666, 5th Floor, Central Police Office, I.I. Chundrigar Road, Karachi by submitting an application on their letterhead along with tender fee from 15-02-2017 to 03-03-2017.
3. Sealed tenders on prescribed proforma in duplicate along with 2% earnest money of the total bid in form of Pay Order (Payee's A/c in favour of DIGP Special Branch Karachi) should be dropped in the Tender Box kept in office of DIGP Special Branch, 5th Floor, Central Police Office, I.I. Chundrigar Road, Karachi on 07-03-2017 at 1300 hrs.
4. The tenders shall be opened on 07-03-2017 at 1400 hours in presence of Procurement Committee and representatives of bidders who choose to be present on the occasion in the Committee Room of DIGP Special Branch Karachi 5th Floor, I.I. Chundrigar Road, Karachi.
5. Only manufacturers / suppliers and authorized dealers registered with Income Tax and Sales Tax Departments are eligible to participate in the tenders (Documentary proof required).
6. Only bids offered on the prescribed tender form issued by the Special Branch Karachi shall be accepted. However, additional sheets may be attached, if required.
7. Conditional tenders / applications will not be entertained.
8. Competent Authority can cancel the bidding process at any time prior to the acceptance of a proposal as per provision of Rule-25(1) of SPPRA Rules, 2010 (Amended 2013).
