

TERMS AND CONDITIONS

1. Rate should be quoted F.O.R destination Sector Headquarters Indus Rangers near Habib Sugar Mills Nawabshah.
2. Prices should be inclusive of all taxes duties and charges of packing, marking and handling etceteras. Quotation indicating sale tax / other taxes separately will be rejected.
3. Sale tax payers certificate and income tax certificate for the current financial year duly attested should accompany the tender as per Government of Pakistan, Finance Division's instructions, otherwise the offer will be ignored / rejected.
4. Tender should be accompanied with call deposit or Bank Draft or Pay Order in the name of Sector Commander Indus Rangers as Earnest Money as per following rates, otherwise tender will be ignored / rejected :-
 - a. Firms registered with Pakistan Rangers (Sindh) - 2% of total value of the tender at the rate quoted by
 - b. By un-registered firm - 3% of total value of the tender at the rate quoted by

5. On acceptance of tender the successful tenders will have to deposit security deposited equal to 5% value of contract within 3 days after receipt of Advance Acceptance of Tender in shape of pay order in the favour of Sector Commander Indus Rangers near Sugar Mills Nawabshah. 5% security will be returned on successful delivery of stores / warranty & Guarantee period.
6. The call Deposit / Bank Draft / Pay Order Deposit with tenders on account of earnest money will be returned to the participant in case of non acceptance of tender within fortnight after the date of opening Tenders.
7. The tender will be opened on **6 March 2017 at 1400 hours**. You are at liberty to be present or authorize a representative to be present at the time of opening of tenders.
8. Items are required to be delivered within one week or earlier from the data of opening of tenders.
9. The offer will remain open for acceptance for a period of one month from the date of opening of tenders.
10. The Sector Commander Indus Rangers reserve the rights to accept or reject any or all tenders without assigning any reason.
11. The Sector Commander Indus Rangers does not pledge himself to accept the lowest of any tender and reserves himself the right of accepting the whole or any part of the tender or portion of the quantity offered and you all supply the same on rate quoted. You are at liberty to tender for the whole or any portion or the state in the tender that the rate quoted shall apply only if the entire quantity is taken from you.
12. The individual signing tender or other documents must specify the capacity in which he is signing the tender documents following etceteras **"(Sole Proprietor / Partner)"** etceteras.
13. The prices should be quoted both in words and figures.
14. In case tender is accepted and supplies made as per orders, the amount of sale tax and Income Tax (if applicable) would be deducted from the amount payable to the firm. Otherwise you would have to provide documentary proof these Government dues have been aid to the Government at the time of submission of the relevant bill.
