2. Prices should be inclusive of all taxes duties and charges of packing, marking and handling etceteras. Quotation indicating sale tax / other taxes separately will be rejected.
3. Sale tax payers certificate and income tax certificate for the current financial year duly attested should accompany the tender as per Government of Pakistan, Finance Division's instructions, otherwise the offer will be ignored / rejected.
4. Tender should be accompanied with call deposit or Bank Draft or Pay Order in the name of Sector Commander Indus Rangers as Earnest Money as per following rates, otherwise tender will be ignored / rejected :-
  - a. Firms registered with Pakistan Rangers (Sindh) - 2% of total value of the tender at the rate quoted by

5. On acceptance of tender the successful tenders will have to deposit security deposited equal to 5% value of contract within 3 days after receipt of Advance Acceptance of Tender in shape of pay order in the favour of Sector Commander Indus Rangers near Sugar Mills Nawabshah. 5% security will be returned on successful delivery of stores / warranty & Guarantee period.
6. The call Deposit / Bank Draft / Pay Order Deposit with tenders on account of earnest money will be returned to the participant in case of non acceptance of tender within fortnight after the date of opening Tenders.
7. The tender will be opened on 6 March 2017 at 1400 hours. You are at liberty to be present or authorize a representative to be present at the time of opening of tenders.
8. Items are required to be delivered within one week or earlier from the data of opening of tenders.
9. The offer will remain open for acceptance for a period of one month from the date of opening of tenders.

11.
