- The amount of Earnest Money must be attached with tender documents as mentioned above against each work. In case of open rate 02% value of quoted tender in shape of pay order in favor of TMA Landhi must be enclosed with Tender document without which the tender will be treated as Cancelled.
- The Contractors must mention their complete and correct present postal address in tender document and quote the rates both in words and in figures. Incomplete / conditional tenders will not be accepted.
- 4. All tenders shall be dropped in the box placed in the Office of the Chairman Tender Opening Committee on or before 22/06/2009 upto 11:30 A.M. The tenders will be opened on the same day at 11:30 A.M. in the presence of contractors / participants who may care to attend. In case the date of opening is declared as a public holiday by the Government or non-working day, the next day shall be deemed to be the date for submission and opening of tenders at the same time.
