Read the Terms & Conditions carefully.

Tenderers are required to comply with all the clauses mentioned in the terms and conditions of the tender any deviation will forbid for competing in the tender.

- In this tender Two Envelopes as per procedure of SPPRA-2010 (46, 2a) will be followed i.e. (i) The bid shall comprise two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal. (ii) The envelopes shall be marked as "Financial Proposal" and "Technical Proposal" in bold and legible letter to avoid confusion each envelope should be drop in separate box (iii)- initially, only the envelope marked "Technical Proposal" shall be opened (iv)- the financial proposals of bids will opened publicly, time, date and venue will be announced later.
