**RULES 473.** The Weekly menu of Mid-day and Evening Meals shall be as under:-

1. Saturday	Dal Masoor with Vegetable	Dal Moong and Rice
2. Sunday	Dal Chana with Vegetable	Beef with Tomatoes Onion & Potatoes
3. Monday	Potatoes with tomatoes & Onion	Dal Moong with Vegetable
4. Tuesday	Vegetables with out leaves	Dal Masoor with Vegetable
5. Wednesday	Potatoes with tomatoes & Onion	Dal Moong with Vegetable
6. Thursday	Dal Chana with Vegetable	Beef with tomatoes Onion & Potatoes
7. Friday	Vegetable with tomatoes with out leaves	Dal Masoor with Vegetable

**NOTE:-** Potatoes instead of beef shall be issued to Hindu & Sikh Prisoners.
