

NOTICE FOR PRE-QUALIFICATION OF CONTRACTORS/FIRMS
PUBLIC HEALTH ENGINEERING DEPARTMENT (SINDH)

The applications for Pre-qualification are hereby invited for the works of "Rehabilitation of Non-Functional Water Supply and Drainage Schemes in Sindh". Contractors/Bidders, who have experience to carry out works and nature of such works are only entitled to apply".

Each Contractor/Bidder/Firm, is required to submit the application on his letter head along with specific qualifications as per eligibility criteria as required.

The firms/contractors must be registered with Pakistan Engineering Council in the relevant category discipline(s) C-5 category and above. The following information/documents are required to be provided with applications for pre-qualification:-

ELIGIBILITY CRITERIA.

- a. The name of Bidder/Firm/Contractor, partnership deed, articles of association in case of Company/Limited firm along with the enlistment / registration particulars.
- b. Registration with Pakistan Engineering Council in the relevant category.
- c. The details of Head office/branch offices with complete address/telephone/fax/e-mail numbers etc and also the name/address of the owner/proprietor/attorney along with attested copies of his/her CNIC should be available with the application.

Projects executed during last 5 years or presently in hand along with their size and quantum/magnitude and period of completion along with completion certificate acquired from the respective Client./Department, must be attached with the application.
- d. The details of Technical Staff presently working with the Firm/Contractor along with their complete bio-data/experience especially supervision of construction of the specific requirement of this Project shall be required with the application. Permanent Business Management, Financial Management and technical staff List of Engineers Sub-Engineers and Draftsman with the firm with experience and standing in the market along with other Technical and Clerical staff and mobile numbers of all the employees to be attached with the application.
- e. The list of work(s) carried out by the Firms/Contractor of above nature during last five years showing cost stipulated/actual period of documentary evidence i.e letter of award etc and completion certificates i/c operation and maintenance such type of projects.
- f. The list of Tools & Plants (Machinery) especially for suitable to carryout subject nature of work(s) in workable condition owned by the Firm/Contractor.
- g. The details of Arbitration or litigation cases where in the Firms/Contractor remained involved. Undertaking on Judicial Paper that the Firm / Contractor was never black listed by any of the Government/Semi Government Organization in the past.
- h. Any Firm responsible for or involved in lapses of funds during last 5 years due to slow progress will not be considered for Pre-qualification.
- i. The registration certificate of Firms/Contractors with Income Tax department along with up to date clearance certificate issued by Income tax Department and also registration with Sindh Revenue Authority as Service Provider.

- j. Proof of financial standing dully supported with documentary evidence/bank statement must be appended with the application.
- k. The firms/contractors have already completed projects or in progress projects if any of the client Federal/Provincial Department must be mentioned.
- l. An affidavit regarding authenticity of all the information provided for prequalification should be attached with the prequalification documents, if any information is found concealed, incorrect, fake or forged:- prequalification will be cancelled, even after the appointment as contractors/Firms/Joint ventures and would be followed by termination and legal action accordingly.

Bank documents to establish financial bid capacity/ of the applicant is desired.

- m. The Application for Prequalification Documents could be acquired from this office address on payment of Rs.2000/-. In the form of Bank Draft, Call Deposit from schedule Banks in the name of Project Director, Rehabilitation of Non-Functional Water Supply and Drainage Schemes in Sindh (Non refundable) timings from 21.03.2017 to 07.04.2017 on any working day upto 2.0 pm on last date of collection of application form.

The application complete in all respect must reach the undersigned on 07.04.2017 upto 2.30 pm. The submission of any fake information/documents shall be considered a serious lapse on the part of Firm/Contractor which will not only disqualify the firm/contractor as per departmental Rules but legal action as may deem proper shall also be initiated against the delinquents. The clarification(s) if required may be got from the office of the undersigned during any working days/hours.

Any concealment about the information details mentioned above will result in rejection of firm / Bidder to participate. In case of incomplete information prequalification / Application will be rejected. The late receipt of application after due date and time mentioned above will not be considered. Applicant firm / bidder are required to give undertaking that they have carefully studied prequalification notice and will abide by the rules and regulations.

Applicant will be informed in the due course, regarding result of the evaluation of applications, Only the Contractors/Firms/Joint Ventures prequalified under this process will be invited in the further processing of this procurement.


Functions and responsibilities:



ALLOCATION 460 MILLION




