1. Karachi Fisheries Harbour Authority (KFHA) invites sealed bids on Item Rate basis from all the interested national bidders on “**Single Stage One Envelope**” procedure under SPPRA Rules 2010 (Amended 2013) for the following work;

2. Eligibility Criteria;

- i) The bidder should provide company profile.
- ii) Valid Registration with Pakistan Engineering Council in Constructor’s Category C-2 or above with specialization codes CE01, CE09, CE10, EE02, EE05 & EE06. The bidders may engage specialized firm(s) as Joint Venture (JV) for any of specialized codes as specified.
- iii) The bidder should have similar experience of at least one (01) Project (a project comprises water supply/ sewerage system, external electrical works and road works) having total cost Rs. 500 million or above completed during last ten (10) years (Letter of Award, scope of work, completion certificates any other relevant documents to be attached). Water supply/sewerage system, external electrical works and road works should have minimum cost of Rs. 100 million each.
- iv) The bidders should have an average annual turnover during last three years Rs.800 million or above as per audited balance sheets from Chartered Accountant firms.
- v) Available bank credit limit (latest) should be at least of Rs. 200 million.
- vi) Income tax returns for the last three years.
- vii) Valid Registration with Income Tax Department and Sindh Revenue Board.
- viii) Affidavit to the effect that the firm has never been blacklisted.

- ix) The bidders should submit details of litigation history and arbitration with government agencies and their outcome.
- x) Affidavit to the effect that all documents / particulars / information furnished are true and correct, if any information found incorrect/misleading, the Procuring Agency reserves the right to reject the bid.

3. **Bidding Documents** will be issued to all interested bidders upon submission of application along with payment of tender fee (*Non-refundable*) in the form of Pay Order in favour of Karachi Fisheries Harbour Authority as per following schedule;

The bids must be accompanied by original Bid Security in the amount of Pak Rs.15,000,000/- (Pak Rupees fifteen million) in the form of deposit at call, Pay order or a Bank Guarantee issued by a Scheduled Bank in Pakistan having AA rating or above in favour of Karachi Fisheries Harbour Authority.


