## **IMPORTANT NOTE:**

## **APPLICABILITY OF SINDH PUBLIC PROCUREMENT RULES-2010 (AMENDED IN 2013):**

This Bidding Process will be governed under Sindh Public Procurement Rules-2010, as amended from time to time.

## **INTRODUCTION:**

The Sind Environmental Protection Tribunal, has newly been established and is situated at 4<sup>th</sup> Floor, State Life Building No.03, Dr. Ziauddin Ahmed Road, Karachi, hence, this office/Tribunal is seeking Authorized Distributors / Proponents who supply New Furniture and Fixtures. Re-furnished and Used items should not be quoted by any Interested Bidder.

## INVITATION TO BID:

### **1.1 SPPRA Rules to be followed:**

Sindh Public Procurement Rules-2010 (Amended in 2013) will strictly be followed. These may be obtained from SPPRA's website:

In this document, unless otherwise mentioned to the contrary, "Rule" means a Rule under the Sindh Public Procurement Rules-2010 (Amended in 2013).

### **1.2 Mode of Advertisement (s):**

As per Rule-17, this Tender is being placed online at SPPRA's website, and advertised in Three Leading News Papers i.e. Daily English Dawn; Daily Urdu Jung; and Daily Sindhi Sobh.

As per Rule-17, sub-rule (4), this Tender along with bidding documents has also been placed online at the website carrying all details and can also be downloaded from SPPRA's website <http://www.pprasindh.gov.pk/>

### **1.3 Types of Opening Competitive Bidding:**

Following Procedure will be followed by Sindh Environmental Protection Tribunal for opening competitive bidding. As per Rule 46 (02), Single Stage-Two Envelopes Procedure would be followed. This is as follows:

- a) The Bid shall contain two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal.
- b) The envelopes shall be marked as **"FINANCIAL PROPOSAL"** and **"TECHNICAL PROPOSAL"** in bold and legible letters to avoid confusion.
- c) Initially, only the envelope marked **"TECHNICAL PROPOSAL"** shall be opened.
- d) Envelope marked as **"FINANCIAL PROPOSAL"** shall be retained in the custody of the procuring agency without being opened.
- e) Procuring agency shall evaluate the technical proposal in a manner prescribed in advance, without reference to the price and reject any proposal which does not conform to the specified requirements.
- f) No amendments in the Technical Proposal shall be permitted during technical evaluation.
- g) Financial proposals of technically qualified bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance.
- h) Financial proposal of bids found technically non-responsive, shall be returned un-opened to the respective bidders.
- i) Bid found to be the lowest evaluated or best evaluated, shall be accepted.

In accordance with these rules, interested companies (hereinafter referred to as **"Bidders"**) applying for bids should submit two separate **Envelopes for Financial Proposal** and **Technical Proposal**.

Technical Evaluation is based on Marks which are assigned to each criteria/ sub-criteria as the minimum Threshold as mentioned in these Bidding Documents.

## **2. INSTRUCTION TO BIDDERS:**

All Bids must be accompanied by an Earnest Money in shape of pay order equal to **02%** of quoted price in favor of **“D.D.O. SEPT”**. The bids along with an Earnest Money, Tender Forms, Affidavits and all required Documents as mentioned in Bidding Documents must be delivered in the office of Sindh Environmental Protection Tribunal, 4<sup>th</sup> Floor, State Life Building No.03, Dr. Ziauddin Ahmed Road, Karachi on or before **12:00 PM** by **18<sup>th</sup> April, 2017**. The Technical Bids will be publicly opened in the office at **01:00 PM** on the same day.

Queries of the Bidders (if any) for seeking clarifications regarding the specifications of the Goods must be received in writing to the following Officer not later than Five (05) working days prior to the deadline for the submission of Bids. Any Query received after such days shall not be entertained. All queries shall be responded to within due time.

The bidder must submit bids on the basis of complete fulfillment of requirements. Failure to meet this condition will cause disqualification of the bidder. The bidder shall submit bids which comply with the Bidding Document. Alternative bids will not be considered. The attention of bidder is drawn to the provisions of clause on **“Determination of Responsiveness of Bid”** regarding the rejection of bids which are not substantially responsive to the requirement of the Bidding Documents

## **TERMS & CONDITIONS OF THE TENDER:**

### **3. DEFINITIONS:**

- 3.1** In this document, unless there is anything repugnant in the subject or context:
- 3.2** “Procuring Agency” means the Sindh Environmental Protection Tribunal or any other person/entity for the time being or from time to time duly appointed in writing by the Sindh Environmental Protection Tribunal to act as Procuring Agency for the purpose of the contract.
- 3.3** “Confirmation” means confirmation in writing.
- 3.4** “Contractor/Bidder/Tenderer” means an entity/ company/organization that is a registered bidder with the Sindh Environmental Protection Tribunal and has submitted its Bid as per the criteria / specifications listed.
- 3.5** “Contractor” means any entity or person that may provide or provides the Goods to any of the public sector organization under the contract.
- 3.6** “Contract” means the contract proposed to be entered into between the Sindh Environmental Protection Tribunal and the Bidder, including all attachments, appendices, and all documents incorporated by reference therein.
- 3.7** “Contract Price” means the price payable to the Contractor under the Contract for the full and proper performance of its contractual obligations.
- 3.8** “Calendar Days” means days including all holidays.
- 3.9** “Fraudulent and Corrupt practices” will have the same bearing and meaning as are defined in General Provision Part-I, in the Sindh Public Procurement Rules-2010 (as Amended in 2013).
- 3.10** “Government” means Government of Sindh.
- 3.11** “In Writing” means communicated in written form e.g. by mail, e-mail or fax, delivered with proof of receipt.
- 3.12** “Person” means individual, association of persons, firm, company, corporation, institution and organization, etc having legal capacity.
- 3.13** “Personnel” means professionals and support staff provided by the bidder that are assigned to perform the Task or any part thereof.
- 3.14** “Procurement Methods” means any one of the procurement modes/methods as provided in the Sindh Procurement Rules-2010 ( as Amended in 2013) published by the Sindh Public Procurement Regulatory Authority (SPPRA), Government of Sindh.
- 3.15** “Proposal” means the Technical Proposal and the Financial Proposal for the provision of the Goods submitted by a Bidder in response to RFP.
- 3.16** “Substantially Responsive Bid”, means the Bid that contains no material differences or Deviations from or reservations to, the terms, conditions and Specifications given in the Bidding Documents.
- 3.17** “RFP” means Request for Proposals, including any amendments that may be made by the Sindh Environmental Protection Tribunal for the selection of bidder.
- 3.18** “Repeat Order”, means Procurement of Additional quantities of the item(s) from the original contractor or supplier, where, after the items originally envisaged for the project have been procured through open competitive Bidding and such additional quantities of the same item(s) of goods are needed to meet the requirements of the project.
- 3.19** “SBD” means Standard Bidding Documents.
- 3.20** “Goods” means the tasks to be performed by the bidder pursuant to the Contract as listed under ***Annexure-G***.

#### **4. HEADINGS AND TITLES:**

In this document, headings and titles shall not be construed to be part thereof or be taken into consideration in the interpretation of the document and words importing the singular only shall also include the plural and vice versa where the context so requires.

#### **5. NOTICE:**

**5.1** In this document, unless otherwise specified, wherever provision is made for exchanging notice, certificate, order, consent, approval or instructions amongst the Contractor, the Sindh Environmental Protection Tribunal and the Bidder, the same shall be:

**5.1.1** in writing;

**5.1.2** issued within reasonable time;

**5.1.3** served by sending the same by courier or registered post to their principal office in Pakistan or such other address as they shall notify for the purpose; and

**5.1.4** The words “notify”, “order”, “consent”, “approve”, “instruct”, shall be construed accordingly.

#### **6. TENDER SCOPE:**

Sindh Environmental Protection Tribunal, (hereinafter referred to as “the Procuring Agency”) invites /requests Proposals (hereinafter referred to as “the Tender”) for the procurement of Furniture and Fixture from Authorized Vendors for the Offices of Sindh Environmental Protection Tribunal.

#### **7. TENDER ELIGIBILITY:**

**7.1** Eligible Bidder is a Bidder who:

**7.1.1** has a registered office in Pakistan;

**7.1.2** has required relevant experience as mentioned at **Annexure- C**;

**7.1.3** has valid authorization in Pakistan;

**7.1.4** has the required relevant qualified personnel and enough strength to fulfill the requirement of assignment as mentioned vide **Annexure- G**;

**7.1.5** Provider of Goods as mentioned vide as per Schedule of Requirements at **Annexure-G** ;

**7.1.6** Conforms to the clause of “Responsiveness of Bid”

#### **8. TENDER COST:**

The Bidder shall bear all costs/ expenses associated with the preparation and submission of the Tender and the Sindh Environmental Protection Tribunal shall in no case be responsible / liable for the any costs/expenses.

#### **9. JOINT VENTURE:**

Joint venture or Partnership firms are not eligible for this Tender. Only those companies which are validly registered with sales tax and income tax departments and having sound financial strength can participate.

#### **10. EXAMINATION OF THE TENDER DOCUMENT:**

The Bidder is expected to examine the Tender Document, including all instructions and



terms & conditions.

#### **11. CLARIFICATION OF THE TENDER DOCUMENT:**

The Bidder may require further information or clarification of the Tender Document, within 10-working days of issuance of Tender in writing.

#### **12. AMENDMENT OF THE TENDER DOCUMENT:**

- 12.1** The Sindh Environmental Protection Tribunal may, at any time prior to the deadline for submission of the Bid, at its own initiative or in response to a clarification requested by the Bidder(s), amend the Tender Document, on any account, for any reason. All amendment(s) shall be part of the Tender Document and binding on the Bidder(s).
- 12.2** The Sindh Environmental Protection Tribunal shall notify the amendment(s) in writing to the prospective Bidders.
- 12.3** The Sindh Environmental Protection Tribunal may, at its exclusive discretion, amend the Tender Document to extend the deadline for the submission of the Tender, in which case all rights and obligations of the Department and the Bidders previously subject to the deadline shall thereafter be subject to the deadline as extended.

#### **13. PREPARATION / SUBMISSION OF TENDER:**

- 13.1** The Tender and all documents relating to the Tender, exchanged between the Bidder and the Sindh Environmental Protection Tribunal, shall be in English. Any Printed literature furnished by the Bidder in another language shall be accompanied by an English translation which shall govern the purpose of interpretation of the Tender.
- 13.2** The Tender shall be filed in / accompanied by the prescribed Forms, Annexes, Schedules, Charts, Drawings, Documents, Brochures, Literature, etc. which shall be typed, completely filled in, stamped and signed by the Bidder or his Authorized Representative. In case of copies, photocopies may be submitted.
- 13.3** The Tender shall be in Two Envelopes i.e. the “Technical Proposal” and the “Financial Proposal”.
- 13.3.1** The Technical Proposal shall comprise and fulfill all the requirements, **without quoting the price.**
- 13.3.2** Tender shall be in Covering Letter duly signed and stamped by authorized representative. **(Annexure-A).**
- 13.3.3** Technical Proposal Form, at **Annexure-B.**
- 13.4** Evaluation Criteria at **Annexure-C.**
- 13.4.1.** Undertaking at **Annexure-D**, All terms & conditions and qualifications listed anywhere in the RFP have been satisfactorily vetted.
- 13.4.2** Manufacturer’s Authorization Form at **Annexure-E.**
- 13.4.3** Affidavit at **Annexure-H.**
- 13.4.4** Form of Bid Requirements at **Annexure-I.**
- 13.4.5** Evidence of eligibility of the Bidder & the Goods.

**13.9.** The Tender shall be mailed to reach and dropped in the Tender Box (1) placed in the Office as mentioned at clause-02, Para-04, during **11:00 am to 2:00 pm**, up to due date and time an/or on the last date upto 12:00 noon.

**13.10** This is made obligatory to affix authorized signatures with official seal on all original and duplicate (copies) documents, annexure, copies, certificate, brochures, literature, drawings, letters, forms and all relevant documents as part of the bids submitted by the Bidder. Non compliance with the same will cause the rejection of bid at the time of opening.

#### **14. TENDER PRICE:**

The quoted price shall be best/final/fixed in PAK Rupees inclusive of all taxes, duties, levies, insurance, freight, etc. If not specifically mentioned in the Tender(s), it shall be presumed that the quoted price is as per the above requirements and valid until completion of all obligations under the Contract i.e. not subject to variation/ escalation. Where no prices are entered against any item(s), the price of that item shall be deemed to have been distributed among the prices of other items, and no separate payment shall be made for that item(s). Each cost should be identified as unit price.

#### **15. EARNEST MONEY:**

**15.1** The Bidder shall furnish the Earnest Money as under:

**15.2** As part of Financial Bid Envelope, failing which will cause rejection of Bid.

**15.2.1** For a **sum equivalent to 02%** of the Total Bid Price;

**15.2.2** Denominated in PAK Rupees.

**15.2.3** Have a minimum validity period of ninety days from the last date of submission of the Tender or until furnishing of the Performance Security, whichever is later;

**15.3** The proceeds of the Earnest Money shall be payable to the Procuring Agency, on the occurrence of any / all of the following conditions:-

**15.3.1** If the Bidder withdraws the Tender during the period of the Tender validity specified by the Bidder on the Tender form; or

**15.3.2** If the Bidder does not accept the correction of his total bid price; or

**15.3.3** If the Bidder, having been notified of the acceptance of the tender by the procuring agency during the period of the tender validity, fails or refuses to furnish the performance security in accordance with the tender documents

**15.4** The Earnest Money shall be returned to the technically unsuccessful bidder with unopened financial bids while the unsuccessful financial bids opening procedure will be the return of the Earnest Money only. The Earnest Money shall be returned to the successful bidder on furnishing the performance security.

#### **16. TENDER VALIDITY:**

The tender shall have a minimum validity period of **thirty (30) days** from the last date for submission of tender. The Sindh Environmental Protection Tribunal may solicit the bidder's consent to an extension of the validity period of the tender. The request and the response thereto shall be made in writing. If the bidder agrees to extension of validity period of the tender, the validity period of the Earnest Money shall also be suitably extended. The bidder may refuse extension of validity period of tender, without forfeiting the Earnest Money.

#### **17. WITHDRAWAL OF THE TENDER:**

**17.1** The bidder may, by return notice served on the Procuring Agency to modify or withdraw the tender after submission of the tender, prior to the dead line for submission of the tender.

**17.2** The tender, withdrawn after the deadline for submission for Bids and prior to the expiration of the period of the tender validity, shall result in forfeiture of the Earnest Money.

#### **18. OPENING OF THE TENDER:**

- 18.1** Tender shall be opened, at the given place, time and date, in presence of the bidder for which they shall ensure their presence without further intimation.
- 18.2** The bidder's name, modification, withdrawal, security, attendance of the bidders and such other details as the Sindh Environmental Protection Tribunal may, at its exclusive discretion, consider appropriate, shall be announced and recorded.
- 18.3** No bidder or its representative will be allowed to keep any digital device (i.e. camera, audio recorder, cell phone etc) during tender opening at given time and location. ***Non compliance will cause the rejection of respective bidder.***

## **19. CLARIFICATION OF THE TENDER:**

The Sindh Environmental Protection Tribunal shall have the right, at its exclusive discretion, to require, in writing, further information clarification of the tender or may require supporting Documents from any or all the Bidder(s). No change in the price or substance of the Bid shall be sought, offered or permitted except as required to confirm the correction of arithmetical errors discovered in the Bid. Acceptance of any such correction would be sole discretion of the Sindh Environmental Protection Tribunal.

## **20. DETERMINATION OF RESPONSIVENESS OF THE BID:**

The Sindh Environmental Protection Tribunal shall determine the substantial responsiveness of the Tender to the Tender Document, prior to the Tender Evaluation Criteria, on the basis of the contents of the Tender itself without recourse to extrinsic evidence. A substantially responsive Bid is one which:

- 20.1.1** meets the Preliminary Evaluation Criteria & De-Evaluation Criteria for the Bidder for the Goods as mentioned vide ***Appendix-1 & Annexure-C;***
- 20.1.2** meets the Technical Specifications for the Goods as mentioned vide ***Annexure-C;***
- 20.1.3** meets the point for the Goods as mentioned vide ***Annexure-C;***
- 20.1.4** meets the rate and limit of liquidated damages;
- 20.1.5** offers fixed price quotations for the Goods as mentioned vide ***Annexure-G;***
- 20.1.6** is accompanied by the required Tender Earnest Money as a part of Financial Bid envelope;
- 20.1.7** is otherwise complete and generally in order;
- 20.1.8** conforms to all terms and conditions of the Tender Document, without material deviation or reservation;
- 20.2** A material deviation or reservation is one which affects the scope, quality of the Goods or limits the Sindh Environmental Protection Tribunal rights or the Bidder's obligations under the contract.
- 20.3** The Tender determined as not substantially responsive shall not subsequently be made responsive by the Bidder by correction or withdrawal of the material deviation or reservation. However, the Sindh Environmental Protection Tribunal may waive off and minor a conformity or inconsistency or informality or irregularity in the Tender.

## **21. CORRECTION OF ERRORS/AMENDMENT OF TENDER:**

The Tender shall be checked for any arithmetic errors which shall be rectified, as follows:

If there is a discrepancy between the amount in figures and the amount in words for the total Bid Price entered in the Tender Form, the amount which tallies with the total Bid Price entered in the Price Schedule, shall govern. If there is a discrepancy in the unit rate and the

total price entered in the price schedule, resulting from incorrect multiplication of the unit rate by the quantity, the unit rate as quoted shall govern and the total price shall be corrected, unless there is an obvious and gross misplacement of the decimal point in the unit rate, in which case the total price as quoted shall govern and the unit rate shall be corrected. If there is a discrepancy in the actual sum of the itemized total prices and the total Bid price quoted in the price schedule, the actual sum of the itemized total prices shall govern. The Bid price as determined after arithmetic correction shall be termed as the corrected Bid price which shall be binding upon the bidder. Adjustment shall be based on corrected Bid Price. The price determined after making such adjustments shall be termed as evaluated total Bid price. The bidder shall rate the Bid price for the payment terms outlined in the conditions of contract which will be considered for the evaluation of the tender. The bidder may state alternate payment terms and indicate the reduction in the Bid price offered for such alternative payment terms. The Sindh Environmental Protection Tribunal may consider the alternative payment terms offered by the bidder.

## **22. REJECTION OF THE TENDER:**

**22.1** The Sindh Environmental Protection Tribunal shall have the right, at its exclusive discretion, to accept a Tender or reject any or all Tender (s), cancel/annul the Tendering process at any time prior to the award of Contract, without assigning any reason or any obligation to inform the Bidder of the grounds for the Sindh Environmental Protection Tribunal action, and without thereby incurring any liability to the Bidder and the decision of the Procuring Agency shall be final.

**22.2** The Tender shall be rejected if it is:

**22.2.1** Substantially non-responsive; or

**22.2.2** Submitted in other than prescribed forms, annexes, schedules, charts, drawings, documents by other than specified mode; or

**22.2.3** Incomplete, un-sealed, un-signed, printed (hand written), partial, conditional, alternative, late; or

**22.2.4** Subjected to interlineations /cuttings/corrections/erasures/overwriting; or

**22.2.5** The bidder submits more than one tenders; or

**22.2.6** The bidder refuses to accept the corrected total bid price; or

**22.2.7** The bidder has conflict of interest with the Procuring Agency; or

**22.2.8** The bidder tries to influence the Bid evaluation/Contract award; or

**22.2.9** The Bidder engages in corrupt or fraudulent practices in competing for the contract award.

**22.3.** There is any discrepancy between bidding documents and bidder's proposal i.e. any non-conformity or inconsistency or informality or irregularity in the submitted bid.

**22.4** The Bidder submits any financial conditions as part of its bid which is not in conformity with tender document.

## **23. PROCURING AGENCY'S RIGHT TO VARY QUANTITIES AT THE TIME OF AWARD:**

The Procuring Agency reserves the right at its exclusive discretion at the time of Contract Award to increase or decrease, by 15%, the quantity of Stores originally specified in Schedule of Requirements without any change in Unit Price or other terms & conditions.

## **24. ACCEPTANCE LETTER (LETTER OF INTENT):**

The Sindh Environmental Protection Tribunal shall, send the Acceptance letter (Letter of Intent) to the successful Bidder, prior to the expiry of the validity period of the Tender, which

shall constitute a contract, until execution of the formal Contract. Upon the successful Bidder's furnishing of the Performance Security, the Procuring Agency will promptly notify each unsuccessful Bidder & will Discharge its Earnest Money.

## **25. PERFORMANCE SECURITY:**

**25.1** The successful Bidder shall furnish Performance Security as under:

- 25.1.1** within Fifteen (15) working days of the receipt of the Acceptance letter from the Procuring Agency;

3. In consideration of the payments to be made by the Sindh Environmental Protection Tribunal to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Sindh Environmental Protection Tribunal to execute and complete the Goods and remedy defects therein in conformity and in all respects within the provisions of the Contract.
4. The Sindh Environmental Protection Tribunal hereby covenants to pay the contractor, in consideration of the execution on completion of the goods as per provisions of the Contract, the Contract Price or such other sum as may become payable of the Contract,

**27. CONTRACT:**

The Sindh Environmental Protection Tribunal shall, after receipt of the performance security from the successful bidder send the contract provided in the Tender Document, to the successful bidder. Within three working days of the receipts of such contract, the Bidder shall sign and date the contract and return it to the Sindh Environmental Protection Tribunal.

**28. CONTRACT DOCUMENTS AND INFORMATION:**

The contractor shall not, without the Sindh Environmental Protection Tribunal prior written consent, make use of the contract, or any provision thereof, or any document(s), specifications, drawing(s), pattern(s), sample(s) or information furnished by or on behalf of the Sindh Environmental Protection Tribunal in connection herewith except for purposes of performing the contract or disclose the same to any person other than a person employed by the contractor in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only as far as may be necessary for purposes of such performance.

**29. CONTRACT LANGUAGE:**

The contract and all documents relating to the contract, exchanged between the contractor and the Sindh Environmental Protection Tribunal, shall be in English. The contractor shall bear all costs of translation to English and all risks of the accuracy of such translation.

**30. STANDARDS:**

The goods provided under this contract shall conform to the authoritative latest industry standards.

**31. PATENT RIGHT:**

The contract shall indemnify and hold the department harmless against all third party claims of infringement of patent, trademark or industrial design rights arising from use of the goods or any part thereof.

**32. EXECUTION SCHEDULE:**

The Contractor shall submit an execution Schedule, giving details of goods rendered, as required under the contract, to the Sindh Environmental Protection Tribunal, immediately after the issuance of letter of Intent.

**33. PAYMENT:**

The contractor shall submit an Application for payment, in the prescribed form, to the Sindh Environmental Protection Tribunal. The Application for payment shall: be accompanied by such invoices, receipts or other documentary evidence as the Sindh Environmental Protection Tribunal may require; state the amount claimed; and set forth in detail, in order of the price schedule, particulars of the goods provided, up to the date of the application for payment and subsequent to the period covered by the last preceding

certificate of payment, if any. Payment shall not be made in advance. The Sindh Environmental Protection Tribunal shall make payment for the goods provided, to the contractor, as per Government policy, in Pak Rupees, through A.G Sindh Cheque.

**34. PRICE:**

The contractor shall not charge prices for the goods provided and for other obligations discharged, under the contract, varying from the prices quoted by the contractor in the price schedule.

**35. CONTRACT AMENDMENT:**

The Sindh Environmental Protection Tribunal may, at any time, by written notice served on the contractor, alter, amend, omit, increase, decrease or otherwise change the nature, quality, quantity and scope, of all /any of the goods with the percentage as prescribed in Bidding Documents. The contractor shall, within ten working days of receipt of such notice, submit a cost estimate and execution schedule of the proposed change (hereinafter referred to as the change), to the Sindh Environmental Protection Tribunal. The contractor shall not execute the change until and unless the Sindh Environmental Protection Tribunal has allowed the said change, by written order served on the contractor. The change, mutually agreed upon, shall constitute part of the obligations under this contract, and the provisions of the contract shall apply to the said change. No variation in or modification in the contract shall be made, except by written amendment signed by both the Sindh Environmental Protection Tribunal and the contractor.

**36. ASSIGNMENT / SUBCONTRACT:**

The contractor shall not assign or sub-contract its obligations under the contract, in whole or in part, except with the Sindh Environmental Protection Tribunal prior written consent. The contractor shall guarantee that any and all assignees or subcontractors of the contractor shall, for performance of any part or whole of the goods under the contract, comply fully with the terms and conditions of the contract applicable to such part or whole of the goods under the contract.

**37. LIQUIDATED DAMAGES:**

If the contractor fails/delays in performance of any of the obligations, under the Contract/violates any of the provisions of the Contract/commits breach of any of the terms and conditions of the contract the Sindh Environmental Protection Tribunal may, without prejudice to any other right of action/remedy it may have, deduct from the Contract Price, as liquidated damages, a sum of money @ 0.25% of the contract Price which attributable to such part of the services as cannot, in consequence of the failure/delay, be put to the intended use, for every day between the scheduled delivery date(s), with any extension of time thereof granted by the Sindh Environmental Protection Tribunal, and the actual delivery date(s). Provided that the amount so deducted shall not exceed, in the aggregate, 50% of the Contract Price.

**38. BLACKLISTING:**

If the contractor fails/delays in performance of any of the obligations, under the contract / violates any of the provisions of the contract/commits breach of any of the terms and

conditions of the contract the Sindh Environmental Protection Tribunal may, at any time, without prejudice to any other right of action/remedy it may have, blacklist the contractor, either indefinitely or for a stated period, for further tenders in public sector. If the contractor is found to have engaged in corrupt or fraudulent practices in competing for, the SEPT may without, prejudice to any other right of action / remedy it may have, blacklist the contractor, either indefinitely or for a stated period, for further tenders in public sector.

### **39. FORFEITURE OF PERFORMANCE SECURITY:**

If the contractor fails/delays in performance of any of the obligations, under the contract / violates any of the provisions of the contract/commits breach of any of the terms and conditions of the contract the Sindh Environmental Protection Tribunal may, without prejudice to any other right of action / remedy it may have, forfeit performance security of the contractor. Failure to supply required services within the specified time period will invoke penalty as specified in this document. In addition to that, performance security amount will be forfeited and the company will not be allowed to participate in future tenders as well.

### **40. TERMINATION FOR DEFAULT:**

If the contractor fails/delays in performance of any of the obligations, under the contract/violates any of the provisions of the contract/commits breach of any of the terms and conditions of the contract the Sindh Environmental Protection Tribunal may, at any time, without prejudice to any other right of action/remedy it may have, by written notice served on the contract indicate the nature of the default(s) and terminate the contract, in whole or in part, without any compensation to the contractor. Provided that the termination of the contract shall be resorted to only if the contractor does not cure its failure/delay, within fifteen working days (or such longer period as the Sindh Environmental Protection Tribunal may allow in writing), after receipt of the such notice. If the Sindh Environmental Protection Tribunal terminates the contract for default, in whole or in part, the Sindh Environmental Protection Tribunal may procure, upon such terms and conditions and in such manner as it deems appropriate, goods similar to those undelivered, and the contractor shall be liable to the Sindh Environmental Protection Tribunal excess costs for such similar Goods. However, the contractor shall continue performance of the contract of the extent not terminated.

### **41. TERMINATION ON INSOLVENCY:**

If the contractor becomes bankrupt or otherwise insolvent, the Sindh Environmental Protection Tribunal, at any time, without prejudice to any other right of action/remedy it may have, by written notice served on the contractor, indicate the nature of the insolvency and terminate the contract, in whole or in part, without any compensation to the contractor.

### **42. TERMINATION FOR CONVENIENCE:**

The Sindh Environmental Protection Tribunal may, at any time, by written notice served on the contractor terminate the contract, in whole or in part, for its convenience, without any compensation to the contractor. The Goods which are complete or to be completed by the contractor, within thirty working days after the receipt of such notice, shall be accepted by the Sindh Environmental Protection Tribunal. For the remaining Goods, the Sindh Environmental Protection Tribunal may elect:

- To have any portion thereof completed/or
- To cancel the remainder and pay to the contractor an agreed amount for partially completed Goods.

#### **43. FORCE MAJEURE:**

The contractor shall not be liable for liquidated damages, forfeiture of its performance security, blacklisting for future tenders, termination for default, if and to the extent his failure / delay in performance / discharge of obligations under the contract is the result of an event of force majeure. If a force majeure situation arises, the contractor shall, by written notice served on the Sindh Environmental Protection Tribunal indicate such condition and the cause thereof. Unless otherwise directed by the Sindh Environmental Protection Tribunal in writing, the contractor shall continue to perform under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

#### **44. TAXES AND DUTIES:**

The contractor shall be entirely responsible for all taxes, duties and other such levies imposed make inquiries on income tax/sales tax to the concerned authorities of Income Tax and Sales Tax Department.

#### **45. CONTRACT COST:**

The contractor shall bear all costs/expenses associated with the preparation of the contract and the Sindh Environmental Protection Tribunal shall in no case be responsible for those expenses.

#### **46. EXTENSION IN TIME FOR PERFORMANCE OF OBLIGATIONS UNDER THE CONTRACT:**

If the Contractor encounters conditions impeding timely performance of any of the obligations, under the contract, at any time, the Contractor shall, by the written notice served on the Sindh Environmental Protection Tribunal (SEPT) promptly indicate the facts of the delay, its likely duration and its cause(s). As soon as practicable after receipt of such notice, the SEPT shall evaluate the situation and may, at its exclusive discretion, without prejudice to any other remedy it may have, by written order served on the Contractor, extend the contractor's time for performance of its obligations under the Contract.

#### **47. STATUTES AND REGULATIONS:**

The Contract shall be governed by and interpreted in accordance with the laws of Pakistan. The contractor shall, in all matters arising in the performance of the Contract, conform, in all respects, with the provisions of all Central, Provincial and Local Laws, Statutes, Regulations and By-Laws in force in Pakistan, and shall give all notices and pay all fees required to be given or paid and shall keep the Sindh Environmental Protection Tribunal indemnified against all penalties and liability of any kind for breach of any of the same. The Courts at Karachi shall have the exclusive territorial jurisdiction in respect of any dispute or difference of any kind arising out of or in connection with the Contract.
