SEPT** shall be submitted as tender fee by mail or by hand latest by **18. 04. 2017** at **12:00 noon**. The Technical bid(s) will be opened on the same day at **01:00 P.M.** while the **Financial Proposal (s)** shall contain the Bid Security and cost offered by the Bidder(s) along with the valid relevant documents as set down in the SBD.
