CNIC of authorized person of the firm from the date of publication till 27.04.2017 during working hours from 09:00 A.M to 05:00 P.M against Rs. 1,500/- (Tender Fee Non-refundable)

- e. The firm/contractor will be required to show evidence of experience, capability in respect of personnel / machinery, financial position etc.
- f. The firm/organization will submit their proposal in sealed envelope till 28.04.2017 till 11:00 A.M.
- g. The rates quoted (including all Govt. taxes) must remain valid for a period of ninety (90) days after opening of the bid, the bid security 2.5% of the estimated cost in the form of Pay Order/bank Draft/ drawn in favor of the DIGP CTD Sindh Karachi must be attached with their proposal.
- h. Committee will open sealed envelope of proposal in the presence of representatives of the applying firms/organization on 28.04.2017 at 12:00 P.M. in DIGP/CTD Sindh Karachi old Circuit House, Near Qasr-e-Naz, Club Road, Karachi.
- i. Black listed firm from Sindh Police & other Govt. department are not allowed to participate in the bid/tender. The contractor/ firm will submit affidavit to effect that they are not black listed.
- j. Payments shall be made for the works on basis of job, unit basis as the case may be on completion of each work on the basis of measurement & verification in accordance with specification/work completion.
- k. The Contractor/firm are advised in their own interest to fully understand the scope of work and quality/quantities. They may also visit the site to assess themselves any additional/incidental work (availability of Electricity, water or any other item) which may come up before or during execution of work of this tender for the reason that no extra cost will borne out by the Police Department for such eventualities nor any extension in time will be provided on such pretext.
- l. The Police Department will not be responsible for any accidental situation of labors in any shape or compensation. The firm will take its precautions at own risks.
