


TERMS AND CONDITIONS OF THE TENDERS

- i) Contract documents and other terms and conditions can be seen and blank tenders can be obtained from the office of the undersigned on any working day during work hours after publication of advertisement upto the dates mentioned above on payment documents charges (Non-refundable).
- ii) 2% of the total bid amount as Earnest Money is to be submitted along with tender documents in shape of Call Deposit of any reputed Bank of Pakistan, in the name of undersigned.
- iii) No conditional tenders will be entertained.
- iv) The tenders will be opened at 2.00 PM in presence of the Committee and Contractors or their authorized agents who are present at the time, other terms and conditions, specifications, drawing & design can be seen in the office of the undersigned on any working day during working hours.
- v) Tenders will be finalized on the availability of funds and other codal formalities.
- vi) If the undersigned happens to be out of the Headquarter on the date of opening of tenders or in case of holiday or any disturbance the same will be opened on the next working day in presence of interested bidders or their authorized agents as per schedule.
- vii) The procuring agency may reject all bids or proposal at any time prior to the acceptance of a bid or proposal under SPPRA Rule-2010.
- viii) Registration with Income Tax Department (NTN Certificate), Copy of NIC & Registration with Sindh Revenue Board (SRB).
- ix) Bank statement from scheduled Bank.
- x) Registration from the Pakistan engineering Council for the current financial year.
