Bid documents will be received up to 12/05/2017 at 01:00 PM at the Office of the Senior Superintendent Central Prison Larkana along with 2% bid security of the total bid price in the shape of pay order / demand draft in favour of Senior Superintendent Central Prison Larkana along with following relevant papers and will be opened on the same day at 02:00 PM by the Committee in presence of bidders or through their representative who wish to be present. If any holiday falls on the opening day of bids, it will be opened on next working day at the given time and venue.

#### Part-II

#### **INSTRUCTIONS:**

#### Scope of Contract:

The Scope of contract shall be the supply, delivery of the stores at the consignee's end, in accordance with the bill of quantities in this bid document.

#### Part-III

#### **SPECIAL TERMS AND CONDITIONS:**

#### 1. Submission of Bids:

- a. Bids must be submitted under a proper letter mentioning important points / enclosures.
- b. Bids should be submitted under Single-Stage-Two-Envelope procedure in a sealed package.
- c. The bid shall comprise a single package containing two separate envelopes. Each Envelope shall contain separately the Financial Proposal and the Technical Proposal With following documents / information noted against each:-

1. TECHNICAL PROPOSAL:	(Bidding documents in original, earnest money, details of specifications of respective item along with samples, Certificate/ Registration with concerned Drug Regulatory Authorities, Sales Tax and Income Tax certificate etc)
2. FINANCIAL PROPOSAL:	(Rate of respective item including all taxes / charges whatsoever).

- d. No conditional offer shall be accepted.
- e. Sealed Bids should be addressed to: The Senior Superintendent Central Prison Larkana, Sindh.

#### 2. Bid Security:

- a. A bid should accompany Bid Security @ rate of 2% of bid cost in shape of call deposit / Pay order.
- b. A bidder offering more than one option / alternative / brand of the same item / product, should purchase separate bidding documents.
- c. Bid security of unsuccessful bidders will be returned after signing of contract or expiry of bid validity period.
- **d.** Bid security shall be forfeited in case a bidder withdraws his bid during validity of bids or fails to fulfill conditions of tender in any way, or in case of a successful bidder fails to fulfill pre-contract or post-contract requirements.

#### 3. Samples

All the bidders should provide **THREE** samples free of cost of the quoted **medicine** at the time of submission of bid. In absence of samples bid will not be considered. Procurement Committee if deemed necessary sample so supplied by the bidder can be tested in the testing laboratory and he will also bear all the expenses / fee of testing laboratory in advance in case of delay or non-compliance bid will be rejected.

#### 4. Packing, Marking and Handling

- a) All the Stores, whether imported or locally manufactured / available, shall be delivered to the consignee's end in safe and secure condition at the risk and cost of the Contractor.
- b) The packing, marking and handling shall be so arranged by the contractor as to prevent any loss of or damage to the Stores.

#### 5. Quantity:

Quantity of advertised items can be increased or decreased or any item(s) can be included/excluded / dropped as per availability of funds.

#### Quality of Stores

The relevant materials, (hereinafter called "Stores") quoted and supplied against this "Bid Notice" shall be strictly in accordance with the Specifications at Annexure "B" attached with this "Bid Document". The Stores shall be the product of an established manufacturer, shall conform to internationally acceptable commercial standards, and shall be a model that has been successfully operated over a reasonable period of time in pharmaceutical or health industry.

The Stores offered by the Bidders must be of a quality suitable for the purpose and operations for which they are required, and must be capable of rendering the required performance and services at site in the local conditions of extreme **tropical climate**.

The Bidders must also warrant the use of best material in the making of the stores by the manufacturers. The use of substandard material shall make the Stores liable to rejection and the Bidder liable to pay compensation. The Bid shall be for **brand new** "Stores" robust in manufacturing according to the modern practices, processes and standards.

If goods are declared substandard the Manufacturer and their Distributor are equally responsible and are bound to supply additional quantity of whole batch free of cost. (in case of failure the contract will be terminated as per relevant rules / conditions etc).

#### 07. Errors in the Bids

Any arithmetic errors found during evaluation of Bids shall be rectified on the following basis.

 If there is discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the Procurement Committee shall correct the total price.

- If there is a discrepancy between the words and figures, the amount in words shall prevail.
- iii. If there is any discrepancy between the total Bid price entered in the Articles of Agreement and the total shown in the schedule of Price, the amount stated in the Articles of Agreement shall be corrected by the Procurement Committee in accordance with the corrected Scheduled of Prices.

If the Bidder does not accept the corrected amount of Bid, his / her Bid will be rejected and the Bid Security submitted with the Bid shall be forfeited.

#### 8. Specifications of Stores/Items

Bidders should provide the following:

- a. Complete specifications: origin and full technical information, as per proforma given in the bid document.
- b. Affidavit on non-judicial stamp paper or company letterhead:
  - The bidder is not blacklisted by any government or semi government organization.

The Supplier shall provide such packing of the Medicine(s)/Items/Stores as is required to prevent their damage or deterioration during transit to their final destination. The packing shall be sufficient to withstand, without limitation, rough handling during transit.

#### Shelf life required

No supply will be accepted having expiry date less than 80% of shelf life for the National manufacturer and 70% for imported items (wherever applicable).

#### GENERAL TERMS AND CONDITIONS:

- Clarification: A bidder shall not alter or modify the bid after the bids have been opened. Procurement Committee may, however, seek or accept clarification to the bid that does not change the substance of the bid.
- Delivery shall be made in 07 days of the contract is signed. Extension in period of delivery can be given on reasonable grounds.
