- E. **Experience and past performance.**
- Complete detail of last 6-12 orders/projects of similar assignments with cost, under-taken in the last three (3) (attach performance certificates of completed orders/projects).
 - Details of 3-6 orders/project in hand indicating name of the client and the scope of work
- F. **Financial.**
- Documentary evidence of financial position, bank statement or audited accounts of the last three (3) years.


