


Subject: **Publication of NIT in National Newspapers**

INVITATION FOR BIDS

The Deputy Commissioner Tando Muhammad Khan/ Secretary Petroleum Social Development Committee (hereinafter called "Procuring Agency") has received an allocation from the Public Fund in Pak rupees towards the cost of "Establishment of Shaheed Mohtarma Benazir Bhutto Cardiac Care Hospital at Tando Muhammad Khan (SMBBCCCH-TMK)". It is intended that part of the proceeds of this allocated fund will be applied to eligible payments under the contract for **"Supply and Installation of 750KVA Transformer and its allied accessories at Shaheed Mohtarma Benazir Bhutto Cardiac Care Hospital Tando Muhammad Khan"** as per approved Design & Standards of HESCO / WAPDA duly registered firms/ suppliers/ manufacturers

1. Bidding will be conducted as Single Stage – One Envelope Procedure as per SPPRA Rules 2010.
2. Interested bidders/suppliers should have following;
 - a) Relevant experience in last 5 years
 - b) Financial Turn Over of last 3 years
 - c) Registration with Pakistan Engineering Council where required in above table.
 - d) Registration with Income Tax and Sales Tax Department
 - e) Undertaking on affidavit that the firm has never been black listed by any agency or in litigation with any agency.
3. Interested eligible bidders can purchase the bidding documents at the office address mentioned below up to 05-07-2017 during working days/hours only.
4. The bidding documents can be purchased by interested bidders on the submission of a written application to the undersigned and upon payment of a nonrefundable fee of Rs. 2000/-
5. Bids must be delivered to the below mentioned office and must be accompanied by a bid security of amount 2% of total quoted bid price in shape of Pay Order/ Bank Draft in favor of Project Director Shaheed Mohtarma Benazir Bhutto Cardiac Care Hospital at Tando Muhammad Khan.
6. Sealed bids must be submitted at below mentioned address latest by 06-07-2017 upto 01:00 pm. Bids will be opened on the same day at 02:00 pm in the presence of members of Tender Committee and bidders who wish to attend the proceedings.
7. The Bidder shall sign and stamp the Form of Integrity Pact provided at Schedule-B to Bid in the Bidding Document for all Sindh Government procurement contracts exceeding Rupees ten (10) million. Failure to provide such Integrity Pact shall make the bid nonresponsive (SPPRA Rule 89).
