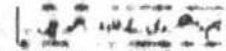

Manner and place, date and time of opening of bids

The bid will be opened at 12:30 pm on 7th July 2017 in the presence of owners of their authorized representatives who intend to be present on the same aforementioned address

Evaluation Criteria

The technical person should concern all information as outlined in the terms of reference / specification whereas the financial proposal should mention the monthly rent inclusive of all government taxes / rates which shall be deducted at the same time of making payment. The technical proposal will be evaluated against the laid down specification and the bungalow on site. The responsive bidder will be notified of the date and time of the opening of financial proposals.

Assessment of tender price

The rent will have to be assessed on monthly basis. The total yearly rent will have to be computed on the basis thereof. It should be inclusive of all government taxes and rates which will be deducted in accordance with the rules at the time of payment.

Currency

Tender price has to be formulated and expressed in Pak Rupees.

Bids Security


