### 2. Terms of References:

- i. Committee may examine the complain of bidder as per SPPRA Rules.
- ii. The Complaint Redressal Committee upon receiving a complaint from an aggrieved bidder may if satisfied.
  - a. Prohibit the Procurement Committee from acting or decision in a manner inconsistent with these rules and regulations.
  - b. Annual in whole or in part, any unauthorized act or decision of the procurement Committee.
  - c. Reverse any decision of the Procurement Committee or substitute its own decision for such a decision.
  - d. Provide that the Complaint Redressal Committee shall not make any decision to award this contract.
- iii. The committee shall announce its decision within seven days. The decision shall be intimated to the bidder and the Authority within three working days by procuring agency. In case of failure of the committee to decide the complaint the procuring agency shall not award the contract.
- iv. The procuring agency shall award the contract after the decision of the Complaint Redressal Committee.
- v. More fact of lodging of complaint shall not warrant suspension of the procurement proceedings.

- The envelope marked as "**FINANCIAL PROPOSAL**" shall be retained in the custody of the procuring agency without being opened.
- The procuring agency shall evaluate the Technical Proposal without reference to the price and reject any proposal which do not confirm to the specified requirements.
- During the technical evaluation no amendments in the technical proposal shall be permitted.
- The financial proposal of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance.
- After the evaluation and approval of the technical proposal the procuring agency, shall at a time within the bid validity period. Publicly open the financial proposals of the technically accepted bids only. The financial proposal of bids found technically non-responsive shall be returned un-opened to the respective bidders; and

The bid found to be the lowest evaluated bid shall be accepted.
