



ORDER

In pursuance of Finance Department's advise No. FD.SO (Dev-VII)/H-1(2)/2017-18, dated 21st July, 2017, sanction of Government of Sindh, is accorded for the release of **Rs.25.000 (Rupees Twenty Five Million Only)** being **25%** released of ongoing development scheme during CFY 2017-18 and placed at the disposal of Project Director Medical College Khairpur. The expenditure incurred will be debited under demand No.56 relating to the head of account "SC-12144-Health Services (Capital)-07-Health-073-Hospital Services-0731-General Hospital Services-073101-General Hospitals Services", for execution of ongoing Development Scheme of Health Sector (Provincial) during CFY 2017-18.

The sanctioned amount should be disbursed to all the subordinate offices/executing agency within 07 days of receipt of the same. A certificate / intimation to this effect should be provided to Finance Department.

No expenditure should be incurred on development scheme(s) unless Administrative Approval is issued / authenticated by the competent authority.

It may be ensured that the expenditure on development scheme project should not exceed current years 2017-18 ADP allocation or actual releases whichever is less. The concerned officer should be held personally responsible for any excess expenditure / any liability created beyond authorization.

The expenditure on the schemes which have completed their projected period & have not been extended or have exhausted their approved cost & have not been revised / approved should not be incurred.

The expenditure shall be strictly according to the provision of the approved PC-I & concerned officer will be held personally responsible for any variation in this regard.

It is requested to deduct the 1% TPM charges from this release and kept disposal of Planning & Development Department, if involved in this scheme under intimation to this Department.

No expenditure shall be incurred on schemes beyond the approved cost.

It may please be ensured that all required codal formalities are fulfilled before utilization of the above funds and utilization reports are sent to this department on monthly basis.
