SHOW CAUSE NOTIC

Whereas, you are alleged to have committed the following acts of misconduct within the meaning of Section 3 of the Removal from Service (Special Powers) Sindh Ordinance, 2000:

"DG Health Services Sindh Hyderabad has informed vide his letter dated 5.11.2013 that due to non-availability of your whereabouts, your record is not maintained / available. Moreover, your whereabouts was asked from your previous place of posting i.e. School Health Services, Karachi, from where, no record is tracable as yet. Besides this, you were found physically not verified in the year 2011. Thus, you remained absent since your promotion to BS 18 from 1995. "This act tantamounts to misconduct on your part"

- 2. Whereas, sufficient documentary evidence is available on the record against you and, I, Chief Secretary, being your Appointing and Competent Authority, am satisfied that there is no need of holding an enquiry.
- 3. Now, therefore, in exercise of the powers conferred upon me by sub-Section (4) of Section (5) of the Removal from Service (Special Powers) Sindh Ordinance 2000. I do hereby dispense with the enquiry and call upon you to show cause within 14 days of receipt of this notice as to why major penalty of "Removal from Service" should not be imposed upon you failing which ex parte decision will be taken against you.
- You may also intimate whether or not you would like to be heard in person.


