**SUB: 3<sup>RD</sup> MEETING OF BIDDER SELECTION COMMITTEE FOR ISSUANCE OF LOI TO POTENTIAL INVESTORS FOR A RUN OF RIVER HYDRO POWER PROJECT AT RD-15, ROHRI CANAL, TALUKA ROHRI, DISTRICT SUKKUR.**

Third meeting of the Bidder Selection Committee was held under the chairmanship of Special Secretary, Energy Department on June 2, 2017 in the Committee Room of Energy Department, 3rd Floor State Life Building No.3, Dr. Ziauddin Ahmed Road (opposite CM House) Karachi. Following attended:-

**PROCEEDING:**

1. The chair welcomed the participants and asked the Secretary of the Committee to start the proceedings and intimate status of recommendations of the committee in previous meeting.
2. The Secretary of the committee briefly described decisions of last meeting and informed that the procedure for selection of the bidder has been initiated. As per Exhibit-4 of RE Policy 2006, the RFQ Document has been drafted for prequalification of the bidders.
3. The Director, Alternative Energy furnished a draft prequalification document (RFQ) and informed that the technical & financial aspects of the draft RFQ Document including Technical Evaluation Report have been reproduced from the previous Document prepared by the consultant in 2012 for development of the project under PPP mode.

4. The chair enquired about the number of hydropower projects initiated under the Policy and their award of tariff and grid approvals. It was informed that no any hydropower project initiated under RE Policy 2006 up till. This project will be 1<sup>st</sup> of its kind in the province. The award of tariff will be determined by NEPRA after the notification of successful bidder as per procedure at Para h and i of the Exhibit-4 (copy attached).

**DECISION:**

6. After deliberations, the Committee finalized the draft RFQ Document and unanimously recommended for submission to the Secretary, Energy Department/Procuring Agency for its approval and necessary action for public advertisement under SPP Rules in vogue.




