- i. Firms having at least 3 years' experience in providing consulting services for Electronic / Manual-Marking & Execution / Invigilation of Student's Assessments or similar nature of projects / assignment.
 - (a) Firm should have experience using Item Response Theory (IRT) mechanisms and at least 03 similar assignments completed in the past 03 years.
- ii. Having a minimum per annum financial turnover of PKR 30 Million.
- iii. Having required registration documents including required tax documentation (NTN, FBR, and SRB etc.)
- iv. List of litigations with clients (if any) and nature of litigations along with an Affidavit on 50/- rupees stamp / bond paper declaring / certifying that the firm has never been blacklisted.




