



Interested bidders shall be required to submit their Technical and Financial Proposals in separate sealed envelopes clearly marked "Technical Proposal" & "Financial Proposal" in bold and legible letters to avoid confusion. Both these proposals shall be enclosed in an outer envelope and shall be submitted as a single package. The financial proposal must be accompanied with 1% of bid security in shape of pay order in favor of Executive Engineer, Minorities Affairs Department, Government of Sindh. Last date of submission of bid is 8th November, 2017 before 2.00 p.m. in the Office of the Executive Engineer, Minorities Affairs Department, Government of Sindh, located at Barrack No. 12, Block 4-A, Sindh Secretariat, Karachi and same shall be opened at the same location in the presence of all bidders who wish to attend at 02:45 p.m. on the date of submission of proposal. 
