- 1.4. Only retailer/whole sellers/distributors can participate in the Tender.
- 1.5. **For retailer/whole sellers/distributors:**
- 1.6. All the Bidders (retailer/whole sellers/distributors) should submit Company Profile with Technical Offer along with the relevant certificate and documents otherwise the bid offer will be ignored.
- 1.7. Photocopy of Drug Registration Certificate issued by Ministry of Health Islamabad.
- 1.8. Tenders must be completed by typing in the column provided / on separate Letter Head duly signed.
- 1.9. The tender must be free from erasing, cutting and over writing. In case of erasing, cutting and over writing, authorized person should initial it duly stamped, else the offer will not be entertained.
- 1.10. The rates of each item should be written in figures as well as in words. Arithmetical errors will be rectified on this basis. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and the quantity, the unit price shall prevail and the total price shall be corrected. In case of discrepancy the price in words will be authenticated and final.
- 1.11. Conditional Tenders against the Govt. Rules / policy will not be considered / entertained / accepted.
- 1.12. Tenders shall be accompanied by Bid Security mentioned as above in form of Pay Order / Demand Draft in favor of Chairman, Zakat Health Welfare Committee, NIMRA, Jamshoro.
- 1.13. The tendered rate should be inclusive of all applicable taxes to Federal & Provincial Govt. or local bodies and will be deducted from the bill of the contractors / suppliers.
- 1.14. All the (applicable) Government taxes (Income Tax / Sindh Sales Tax (if applicable) will be deducted from the bills of the Contractors / Suppliers.
- 1.15. If the Contractors / Suppliers require Tax exemption facility regarding non deduction of Advance Income Tax vide CR No. 1(10)WHT/2001, dated 11<sup>th</sup> April, 2002, the required documents shall be submitted. - 1.16. One "**SAMPLE TENDER PROFORMA**" is supplied with the list of items to be purchased. The items have to be quoted on the Proforma; duly filled stamped & signed by the authorized bidder. Only those items shall be typed on the Proforma / separate letter head (as per serial of Proforma) for which the rates are to be quoted. - 1.17. Schedule is prepared with the generic name; however the bidder may also mention the brand name against the generic name.
- 1.18. Registration number, make or origin of the country of the drug must be mentioned for each item, for which quotation is given, otherwise it will not be considered. The bidder will also provide original warranty of Manufacturer / Importer with Batch number and Quantity at the time of supply of medicines.
- 1.19. The quoted rates once offered by the firms will not be changed during the contract period.
- 1.20. It is mandatory that drugs quoted are registered with the Federal Ministry of Health.

- 1.21. The supplies should be in commercial pack as per drug act 1976 and delivered at the designated place of NIMRA Cancer Hospital, Jamshoro by the authorized representative of the firm at the risk and cost of the supplier. Any breakage or shortage of stock will be recovered from the supplier.

**All documents should be submitted duly paginated / flagged and the detailed of the documents should also be mentioned in front of the Index.**

**2. SPECIAL CONDITIONS:**

- 2.1. Stores are required as and when required basis. The bidder may, however, give their short guaranteed delivery period by which the supply will be completed positively.
- 2.2. The bidders shall quote their firm and final price both in figure and in words on free delivery basis to NIMRA Cancer Hospital, Jamshoro.
- 2.3. The supplier of sub-standard adulterated spurious, counterfeit, misbranded or contaminated medicine(s) item(s) etc, may be black listed by the competent authority as per judgment of the drugs court or any other authority whose decision will be final and in accordance with the offence and hence their earnest money may not be released till the case is decided by the court or any other authority.
- 2.4. If goods are declared sub-standard the supplier is responsible and are bound to supply additional quantity of whole batch free of cost.
- 2.5. The drugs shall be accompanied by the necessary warranty on Form 2-A (on non-judicial stamp paper) in accordance with the provision of the Drugs Act 1976 and rules framed there under.
- 2.6. The supply should be executed in minimum number of batches.
- 2.7. The Technical evaluation carried out by the Formulary Committee NIMRA Cancer Hospital, Jamshoro will be final, which will be assessed on clinical experience basis of the consultant (s) in the relevant specialty.
- 2.8. Only items approved by the Formulary Committee will be considered by the Procurement Committee.
- 2.9. If a sample of a batch of drug or item is declared in contravention of section 3 / 23 of drugs act 1976 on the basis of test analysis report of Formulary Committee NIMRA Cancer Hospital, Jamshoro or on presence of any foreign particle seen by the competent authority, those will be destroyed and payment will not be made to the supplier. The supplier will be responsible to provide the fresh stock of standard quality within 45 days against the rejected batch. Otherwise amount equivalent to the supplied quantity of defective goods will be deducted from their bill and action will be initiated against the offending firm according to the Drugs Act. 1976 on terms and condition of the tender, whichever is applicable.
