If any fake documents found then CDGK is liable to reject / cancel the tender / work without any compensation and penalize as per rules. 2% Earnest Money in shape of pay order / Bank Guarantee from any schedule Bank as mentioned above should also be enclosed along with the application for issuance of tender documents failing which tender documents will not be issued. Earnest Money equal to 2% of the **offer amount** of the work should be enclosed along with tender in shape of pay order / Bank Guarantee from any schedule bank in favor of CDGK. No tender will be sold on the tender opening date.

The tender in sealed cover superscripted with the name of work should be dropped in the tender box kept in the office of the Executive District Officer (Works & Services) 4<sup>th</sup> Floor, Civic Center, University Road, Gulshan-e-Iqbal, Karachi by **12:00 pm** on 08-09-2009 and opened on the same day at **12:30 pm** in the Committee Room of Works & Services Department, CDGK 4<sup>th</sup> Floor, Civic Center, University Road, Gulshan-e-Iqbal, Karachi in presence of those bidders or their representative who wish to be present.

In case of any reason, if the tenders are not responded on the above dates the next date of submission and opening will be 17-09-2009 and the tender documents will also be available for sale from 09-09-2009 to 16-09-2009.

In Case the date of opening declared as a public holiday by the Government, the next official working day shall be deemed to be the date for submission and opening of tenders at the time as mentioned above.

The total bid amount as well as the rates of items must be filled both in figures and words and in case any correction made by the contractor himself then each correction must be initialed by the Contractor, otherwise the tenders are liable to be summarily rejected.
