

NOTICE FOR INVITING RE-TENDER

Sealed Tenders are invited from the interested bidders meeting the eligibility criteria of "Sindh Public Procurement Regulatory Authority (PPRA) Rules 2004 for ADP scheme N0: 1274 (2008-09) i-e." Up-gradation of THQ Hospitals to the level of DHQ Hospitals in Sindh at TANDO MUHAMMAD KHAN & TANDO ALLAH YAR.

1. The blank tender forms can be had from the office of the **Project Director Rehabilitation of DHQ and THQ Hospitals in Sindh". Resource Centre, second floor, Directorate of Nurses. Kalapul, near Naval Heights, Karachi, from 22nd August, 2009**, upon written request on letter head subject to payment of Rs. 3000/= (Rs. Three Thousands only) as per PPRA rules. 2. The last date of receipt of Tender is 7th September, 2009 up to 12:00 Noon and will be opened on same day at 1:00 PM in the presence of tender opening / evaluation committee and the bidders or their authorized representatives who wish to be present.
3. If due to unavoidable circumstances , the undersigned is out of head quarters , or in case the tenders are cancelled / rejected or un responded , the next date for issue and opening will be as under:
 - a. Issue 08 - 09 - 09 up to and opening on 09 - 09 - 09.
 - b. Issue 10 - 09 - 09 up to and opening on 11 - 09 - 09.
4. Eligibility conditions for intending participants are as under:
 - a. Full name of the firm along with organizational structure and permanent address with telephone number, fax number and e-mail.
 - b. Details of works executed by the contractors in the past ten years indicating scope of works, estimated cost and time taken for completion duly certified by the concerned officials.
 - c. List and location of equipments, transport and machinery available with the contractor for this job.
 - d. Affidavit that the contractor has neither been black listed by any agency nor involved in any subversive activities.
 - e. Copy of fresh enlistment letter of Pakistan Engineering Council in C-1 / C-2 category.
 - f. Bio-data of the technical staff permanently employed and available with the firm/contractor for this project.

- g. List of cases entered into arbitration/Litigation. If not involved then affidavit to the effect that the firm /Contractor was not involved in any litigation, no work was rescinded in the past.
 - h. List of works where penalty is involved, if any.
 - i. Income tax returns of last three years duly certified / verified.
 - j. Any additional information the applicant may like to furnish in support of its papers.
5. The earnest money specified should be in the name of Project Director Rehab: of DHQ and THQ Hospitals in Sindh” in the shape of call deposit / pay order i.e 2% of bid price quoted, from any scheduled bank and must be attached with sealed bid documents, otherwise it will not be entertained.
 6. If firm / partner involved in partnership deed, then complete details / instructions and power of attorney will be submitted in affidavit by the proprietor.
 7. Conditional and Telegraphic tender will not be entertained.
 8. The competent authority reserves the right to reject any or all tenders/ bid proposals, subject to the relevant provisions of PPRA rules.
 9. The bidding will be one stage-two envelope procedure & i.e. technical proposal and financial proposal marked separately duly sealed in single package.
 10. Works will be carried out as per the specifications of our Civil Consultant, appointed by Health Department Government of Sindh.
