



  - (b) Annul in whole or in part, any unauthorized act or decision of the procurement committee.
  - (c) Reverse any decision of the procurement committee or substitute its own decision for such a decision; Provided that the complaint redressal committee shall not make any decision to award the contract.
- (3) The committee shall announce its decision within seven days. The decision shall be intimated to the bidder and the Authority within three working days by
