2. A complete set of bidding documents may be purchased by an interested bidder on submission of a written application to the office of undersigned and upon payment of a non-refundable fee Rs: 3000/- Rupees (Three thousand) only.

Tender must be accompanied by a bid security in the amount of 5% in shape of call deposit from any scheduled bank of Pakistan in favour of the Executive Engineer Jamrao Division Mirpurkhas and must be delivered to the undersigned at or before 12 Noon on **21/12/2017**. Tender will be opened at 1.00 PM on **21/12/2017** before procurement committee in the presence of bidders representatives who choose to attend at the same address.
4. Procuring agency reserves right and reject all bids or proposals as per SPPRA Rule 2010 (Amended 2013)
5. Only eligible bidders with the following qualifications should participate in this bidding viz:
 - Registered with Pakistan Engineering Council in relevant category of the above work.
 - Has completed at least two contracts of C.C Lining in Sindh each with a value equivalent to PKR 600 Million during last three years i/c satisfactory completion certificates.
 - Has an average annual turnover of amount equivalent to PKR 600 million during the last (3) years.
 - List of equipment / machinery and qualified staff required in C.C Lining available with the firm.
 - The under taking / Affidavit on stamp paper by firm /contractor to the effect that neither firms/contractor have ever been black listed / defaulted nor involved in legislation with any Government Department
 - The contractor/firm should be registered with Federal Board of Revenue, Sindh Revenue Board and other relevant tax authorities.
 - Completed at least two contracts of lining in Sindh, each with a value equivalent to works PKR 600 Million.
