On acceptance of tender the successful tenders will have to deposit security deposited equal 5% value of contract within 3 days after receipt of advance acceptance of tender in shape of pay order in the favour of Director General Pakistan Rangers (Sindh) 5% will be returned on successful delivery of stores / warranty & Guarantee period.
6. The call deposit / bank draft / pay order deposit with tenders on account of earnest money will be returned to the participant in case of non acceptance of tender within fortnight after the date of opening tenders.
7. The tender will be opened on 12 January 2018 at 1400 hours. You are at liberty to be present or authorized a representative to be present at the time of opening of the tender at the date and tie as specified above.
8. Items are required to be delivered within one week or earlier from the date of opening of tenders.
9. The offer will remain open for acceptance for a period of one month from the date of opening of tender.
10. The Director General Pakistan Rangers (Sindh) reserve the rights to accept or reject any or all tenders without assigning any reason.
11. The Director General Pakistan Rangers (Sindh) does not pledge himself to accept the lowest of any tender and reserves himself the right of accepting the whole or any part of the tender or portion of the quantity offered and you all supply the same on rate quoted. You are at liberty to tender for the whole or any portion or the state in the tender that the rate quoted shall apply only if the entire quantity is taken from you.
12. The individual signing tender or other document must specify the capacity in which he is signing the tender documents following etceteras "(Sole Proprietor / Partner)" etceteras.
13. The prices should be quoted both in words and figures.
14. In case tender is accepted and supplies made as per orders, the amount of sale tax, income tax and Sindh Sale Tax (if applicable) would be deducted from the amount payable to the firm. Otherwise your would have to provide documentary proof of these Government dues have been paid to the Government at the time of submission of the relevant bill.
