- 2- The Health department now invites sealed bids in accordance with SPP Rule 46(2) **“Single Stage – Two Envelope procedures”** from well reputed and original manufacturers or their authorized dealers / Distributors registered with Sales Tax, SRB and Income Tax department for procurement of Various Medical Equipments, Furniture & Fixture etc for Establishment of Benazir Institute of Urology & Transplantation (BIUT) at District Shaheed Benazirabad.

- 5- Only Technical bids/ proposals will be opened on **23-01-2018 at 4:00 PM** before the procurement committee in the presence of bidders/ their representative of the firms at the above mentioned office.
- 6- A pre-bid conference/ meeting will be held for all interested bidders on **10-01-2018 at 2:30 PM** at the office of Additional Secretary (PM&I), Health Department, 3<sup>rd</sup> Floor, Tughlaq House, Sindh Secretariat Building No.02, Kamal Atta Turk Road Karachi.
- 7- The rates shall be quoted in Pak rupees and should be inclusive of GST, SRB (where applicable), Income Tax etc. GST will be deducted at source at the prescribed rates. The further details are enclosed in the bidding documents.

- 8- The Bid Security of 2.5% of the quoted price must be submitted alongwith bids on bid submission date in the shape of pay order/ Call deposit in the name of "**Project Director, Benazir Institute of Urology & Transplantation (BIUT) at District Shaheed Benazirabad**". The bid validity period is of (90) days as per SPPRA Rules 2010 (Amended 2017).


