- Interested Manufacturers/Suppliers and authorized dealers may obtain the tender document along with tender fees Rs. 500/- each from Mr. Araf Shah, Assistant Sub-Inspector of Special Branch Karachi Cell No. C300-9252074 & Office No. 021-99212666, 5th Floor Central Police Office, I.I. Chundrigar Road, Karachi by submitting an application on their letter head along with tender fees from 15.01.2018 to 30.01.2018.
- Sealed tenders on prescribed proforma in duplicated along with 2% earnest money of the total bid in the form of Pay Order (Payee's A/C in favour of DIGP Special Branch Karachi) should be dropped in the tender box kept in office of DIGP Special Branch, 5th Floor, Central Police Office, I.I. Chundrigar Road, Karachi on 31-01-2018 at 1400 hours.
- The tender shall be opened on 31-01-2018 at 1500 hours in Presence of Procurement Committee and in presence of representatives of bidders who choose to be present on the occasion in the Committee Room of DIGP Special Branch Karachi 5th Floor, I.I. Chundrigar Road, Karachi.
- Only Manufacturers/Suppliers and authorized dealers registered with Income Tax and Sales Tax department are eligible to participate in the tenders (Documentary proof required).
- Only bids offered on the prescribed tender form issued by the Special Branch Karachi shall be accepted. However, additional sheets may be attached, if required.
- Conditional tender application will not be entertained.
