



6. **Time of Delivery of Good:** The delivery should be made by the supplier at the residences of the Hon'ble Judges within 15 days of issuance of purchase order.
7. **Delayed Delivery:** 2% penalty of the total amount will be imposed per week for which the company/firm/agency failed to deliver within the delivery/execution period.
