

The bids can be submitted in the name of Secretary, Food Department up to 13<sup>th</sup> February, 2018 at 11:00 A.M and will be opened on the same day at 12:30 Noon before the Additional Secretary, Food Department/ Chairman Purchase Committee & intending bidders who choose to be present on the occasion. In case of a holiday by the Government, the tender will be opened on next working day.
- 22. The vendor / Bidders are required to attach the relevant brochures & explicitly mention in their Quotation Technical Specifications of their products. Make / Model, Brand Country of Original/ Manufacturing Country, (False declaration Brand's Manufacturing Country may result in rejection of the bid).
- 23. Quotations shall be in accordance with the specification as mentioned in Tender Documents.
- Prices shall be quoted in Pakistani Rupees and shall be inclusive of all applicable taxes and duties & should cover at various locations in Sindh.
