Applications are invited upto 29<sup>th</sup>, September, 2009 in Sealed Covers addressed to the undersigned on the below mentioned mailing address from the Consulting Firms of repute (Local and Foreign Firms) to participate Individually or through Joint Venture for Pre-qualification to undertake the following jobs.

1. Physical Survey and Contour Plan of site including plain tabling for an area approx 12 Acres.
2. Geo-Physical Investigation at site of work including Soil Testing so as to obtain bearing capacity at various points.
3. Preparation of Master Plan, incorporating all details i.e. Civil Works, Water Supply & Sewerage Lines, Sui Gas Lines, Roads, Walk ways, Street Lights, Landscaping and Tree Plantation.
4. Preparation of Architectural / Structural Drawings & Design including Water Supply & Sanitary, Electrification, Sui Gas, Telephone, Intercom System, Audio and Video System, Fire Fighting System, Fire Detection System, Security System, Heating, Ventilation and Air-Conditioning System and Modern Electronic and Computer System.

  - e. Details of similar projects with cost, carried out during the last five years (with brochures, if any).
  - f. List of cost and completion date of Projects in hand indicating name of clients, gist of work etc.
  - g. List of litigation with the clients (if any) and nature of litigation.
  - h. Proof of financial stability and Income Tax return certificates for the last three years.

- i. Affidavit that the firm has never been black listed.
- j. A work plan, indicating a list of proposed staff to be employed on the job, if entrusted upon the firm.
